Subject: Complaint against Khudiram Das for Brutal Physical Assault, Attempt to Murder, Criminal Intimidation and Continuous Torture.

Respected Sir/Madam,

I, **Chandana Das** (64), W/o Late Santosh Das, R/o Durgadas Colony, Netaji Subhas Road, Subhaspally, Ward no. 20, Siliguri, working as a cook at Tikiapara ICDS centre, do hereby lodge this formal complaint against my younger son-in-law, **Khudiram Das**, S/o Late Narayan Das, R/o Liusipakhari, Phansidewa, as follows:

1. **History of Violence:** The accused married my younger daughter, Subhadra Das, in 2002. Since then, he has subjected her and her children to extreme physical, mental, and economic torture. Multiple cases are already pending against him at your station, including Siliguri PS **Case 40/18 (02/03/2018)**, Siliguri PS **GDE no. 91 (02/08/2018)**, Siliguri PS **Case 74/23 (07/06/2023)**.
2. **Current Grievance:** In 2018, the accused drove my daughter and her two children out of his house. They have since taken shelter in my house. My daughter works as a maid to survive.
3. **Incident on 19/03/2026:** At approximately 3.30pm, and again in evening at approx. 6.30 pm the accused forcibly entered my house and brutally assaulted my daughter, Subhadra Das and me. He used extremely foul and derogatory language against my

elder daughter and granddaughters. Subhadra sustained severe injuries and was treated at **Siliguri Hospital**. Regarding this matter we contacted in the Emergency Response Support System 112 for police assistance and in the basis of the complaint in 112 bearing registration id 307553 (WB20260319000274) police petrol van of Siliguri PS has also visited in my house near about 7.30 pm.

Photostat copy of medical report of physical assault of Subhadra Das is here annexed as A1.

4. **Attempt to Murder on 20/03/2026:** On 20/03/2026 at about 2:00 PM, while I was at my residence, the accused attacked me from behind in a heavily intoxicated state. I fell to the ground, and he continued to assault me. He explicitly threatened to kill me, shouting that he would not stop until I "registered" my house and property in his name. He is using violence as a tool for **extortion of my all movable and immovable property.**

5. **Urgent Threat:** The accused is a habitual offender and is currently roaming free, posing continuous a direct threat to the lives of myself, my two daughters, and my grandchildren. We are living in a state of absolute terror.

PRAYER: I, therefore, earnestly request you to treat this as a formal FIR, arrest the accused immediately to prevent further harm, and take strict legal action under the relevant sections of the law.
