Sub: Written complaint against unknown miscreants who barged into my house and stole cash of Rs 6,05,000/- (Rupees Six Lakh Five Thousand) only which was my working capital of my second hand two wheeler business.

Sir,

I **Sri Partha Sarathi Ghosh**, Son of Sri Tushar Kanti Ghosh, resident of Chittaneer Apartment, Opposite Tarai School Maidan, Deshbandhupara, Post Office & Police Station-Siliguri, District-Darjeeling do hereby inform you that yesterday our whole family went to Falakata to meet my maternal aunt in order to offer our condolences for the death of my maternal uncle.

We went to falakata at about 9:05 A.M in the morning and returned at about 08:15 p.m.

On returning our house we found that the hash bolt of both the lock broken, when we went inside the house we found that the thieves have specifically taken the money from the drawer on which we keep cash and has stolen a sum of Rs 6,05,000/- (Rupees Six Lakh Five Thousand) only kept in two separate bags which was my working capital of my second hand two wheeler business and was kept to be deposited today on 04.04.2026.

The bags in which the cash were kept also contained my original Voter Card, PAN Card, Aadhar Card, Driving License, ATM Card, my wife's namely Nibedita Saha's original PAN Card, Aadhar Card, Driving License, ATM Card my mother in laws namely Smt. Shipra Saha's PAN Card, Aadhar Card and ATM Card, my sister in laws namely Sangeeta Saha's original PAN Card, Aadhar Card, ATM Card, my father in laws namely Late Narayan Chandra Saha's original Voter Card, Adhar Card.

I therefore request your good office to take necessary action against the unknown miscreant for stealing my hard earned money of Rs 6,05,000/- (Rupees Six Lakh Five Thousand) only recover the same and return it to me through due process of law and also put the perpetrators behind the bars.

Please treat this as very urgent and act accordingly.
