Most Humbly, Sri Sintu Sahu, , Son Of Sri Rajkumar Sahu, Presently Residing At Ganga Nagar, Ice Factory Road, Ward No-5 Of SMC, P.O & P.S-Siliguri, Dist-Darjeeling do Here By Lodged This Complaint Against Person Namely 1.Munna Sah Resident of Santoshi nagar 2. Kishor Das 3. Prem Das 4. Junglibeen 5. Sujit Das all resident of Matigara, Tombajote, Under Matigara Police Station, Dist-Darjeeling before you to the effect stating that my brother-in-law namely Radhey shyam sah Son of Late Ram Narayan Sah is the possession holder of land situated at Tombajote behind Narayani Gas Godown, under Matigara Police Station, Dist-Darjeeling and in this land he was constructed one tinshed room since last 5 years.

That today on dated-1/04/2026 around 10:45 AM Morning I came to know that some anti social elements enter in my relative land and started demolished tinshed structure and take all the iron rod, Tin illegally, when I arrived in the place then I saw that all the persons whom names mentioned in this application are present in the property and loaded all the iron rod a tin in a Toto E-Rickshaw, when I ask them why they demolished the room then they all the persons said that the land owner is not giving us money and started demanded money from me Rs.10,00,000/- (Ten Lac) as extortion money.

When I say that why we paid them then they suddenly started abusing me in filthy languages and forcefully keep my motor cycle key and started assaulting physically when I felt down on the ground Person namely Sujit Das attacked me by a sharp weapon (Khukari) and attacked on my neck but I saving my life I hold the Khukari by my hand resulting in my hand gone cut and blood flow started from my right hand suddenly another persons started heated me by iron rod which was kept by them and they attacked on my left leg due to this I was badly injured, they also snatched my Cash money which was I kept in my pocket Rs.2750/- & Gold Chain, and when I started shouting loudly and when my relatives and brother reached at the incident place then they also assaulting them but when the local people are came and gheathered then they ran away from the place and my relatives took me Siliguri District Hospital for treatment.
