**Subject: Information regarding the theft of a domestic LPG cylinder.**

I Mayukh Biswas, Assistant Professor, Department of Library and Information Science, University of North Bengal, son of Mihir Kumar Biswas, residing at W/274 Professors Quarters, University of North Bengal, would like to bring to your notice a theft that occurred at my residence.

Incident Details:

- Date of Incident: December 09, 2025
- Approximate Time: Around 1900 HRS.
- Location of Theft: Inside Quarter

Item Description: The stolen item is a domestic LPG cylinder with the following details:

- Gas Company: Indane
- Consumer ID: 7221622459

Description of Incident: On 09.12.2025 around 1900 HRS, I was in my university provided quarter, W/274 Professors Quarters, University of North Bengal when suddenly a sound came from outside and my pet dog started barking continuously and surprisingly when I went to check the reason while opening the door it was locked from outside while I was inside. The entrance door downstairs was locked by me when I entered my premises. I called my colleague and threw him the keys from my window downstairs, he unlocked, opened the gate and came up to confirm my suspicion of me being locked out while I was inside. The incident was immediately reported to the Watch and Ward Department of the university and they came to see but no solution was provided for recovery of stolen items. Few household items and two cylinders was stolen from the aforementioned quarters. I am filing this report so that the necessary legal action can be taken and to facilitate the process of recovery of the cylinders.

I request you to kindly register a General Diary entry regarding this matter and provide me with an acknowledged copy of the same.
