Sir,

In producing herewith one arrested accused person named Sachin Barman (M/46 yrs), s/o Somaru Barman of - Pelkujote, PO-Ranidanga, P.S. - Matigara, Dist - Darjeeling along with Ground of Arrest, memo of arrest, Seizure List and seized articles (i) 07 (Seven) Sealed Bottles of kingfisher Strong Imperial Beer, each bottle containing 650 ML, and Rs. 160/- each bottle, and marked as Exhibit "A" out of which 01 bottle of each liquor taken as sample for examination and marked as Exhibit "A-1".

I, ASI Bhanu Pradhan along with C/1085 Mithun Debnath and C/500 Mayaram Oraon all of NBMC OP Under Matigara P.S while conducting special raid against anti social elements, warrantees, ID liquor etc in vehicle no WB 02 AT 2965 at different area under NBMC OP, in course of which I received an information from source that a person is selling illicit Liquor in a clandestine way at Kawakhali, Bidhnapally market road under Matigara PS.

Today i.e on 03.04.2026 at 21.35 hrs, I, ASI Bhanu Pradhan of NBMC OP, Matigara P.S., was conducting a special raid focused on anti-social elements, warrantees, and illicit liquor. I was accompanied by C/1085 Mithun Debnath and C/500 Mayaram Oraon, utilizing vehicle number WB 02 AT 2965. While patrolling various areas under the NBMC OP jurisdiction, I received credible information from a source stating that a person is clandestinely selling illicit liquor at the Kawakhali Bidhnapally market road, under Matigara P.S. During raid, I found one Sachin Barman (M/46 yrs), S/O Somaru Barman of - Pelkujote, PO-Ranidanga, PS - Matigara, Dist - Darjeeling is possessing (i) 07 (Seven) Sealed Bottles of kingfisher Strong Imperial Beer, each bottle containing 650 ML, and Rs. 160/- each bottle (Total amount Rs 1120/-) hidden inside road side of market area and selling it to the customers in concealed manner. I demanded papers and license / cash memo of those seized articles but he failed to produce any documents in support of his possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and had been selling the same illegally to the people. I accordingly, seized those illicit liquors in presence of witnesses after preparing proper seizure list duly signed by the witnesses as well as the accused and also labeled the same. Then, I arrested his u/s -35(1) of BNSS with help of Police personnel. The search seizure, label and arrest were made from 22.44 hrs to 22.57 hrs. Then we left the place with the arrested person and the seized articles.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Sachin Barman (M/46 yrs), s/o Somaru Barman of - Pelkujote, PO-Ranidanga, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
