Sir,

In producing herewith following seized articles as per seizure list viz :- (i) One white colour goods carrier vehicle (Truck) having registration No. WB/76/A/7054 loaded with illegally mined river bed materials along with its key.

I, ASI Bikash Roy of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicle having registration number WB/76/A/7054 to the effect that on 03.04.2026 at 14.05 hrs I received secret source information that one Truck bearing Reg. No. WB/76/A/7054 loaded with illegally mined river bed materials is coming towards Champasari side from Mahananda river bed, Milan More area via Kolabari area under Pradhannagar P.S without any valid documents. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 168 dated 03.04.26 and informed the fact to you. As per your kind order and direction myself along with force had been to Kolabari area under Pradhannagar P.S. At around 14.40 hrs we reached at Kolabari area and from a considerable distance we noticed that one truck loaded with rived bed materials was coming towards Champasari. Accordingly, we proceeding towards the said truck but seeing the Police van the driver of the said truck parked the truck on the road and fled away. We tried to apprehend the driver but in vain. After physical verification it is found that the truck is loaded with illegally mined river bed materials. I searched the driver and owner of the truck but nobody could able to provide any information regarding driver and owner of the truck. During local enquiry it could be revealed that the driver and owner of the vehicle having Regn No WB/76/A/7054 mines such illegal river bed materials from Mahananda River illegally and loaded the same in the vehicle having Registration Number WB/76/A/7054 with a views to sale the same to their designed customers for their illegal gain. Accordingly, I seized the said detained truck having Registrtion Number WB/76/A/7054 loaded with illegally mined river bed materials under proper seizure list in presence of witnesses at the spot. The seizure was made in between 14.55 hrs to 15.15 hrs under the video coverage of vediography as per norms of BNSS.

Under the above circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the driver and owner of the vehicle bearing registration number WB/76/A/7054 and arrange for its investigation.
