I, Smt. Sanju Devi Sah, wife of Sri Sibaji Sah, residing at Devi Danga, Middle Palash, P.S. Pradhan Nagar, Darjeeling, most humbly beg to state the following:

On 30/03/2026, at approximately 04:45<sup>8</sup> am, when my husband went to Devi Danga, near Bangla School o fetch milk<sup>water</sup>, at that time a woman namely Sabina Subba (residing at Milan More) struck my husband with her vehicle while driving at a very high speed. My husband was thrown from his bicycle and sustained severe injuries. He is currently admitted to Shanti Hospital. The aforementioned Sabina Subba took my husband to the hospital to facilitate his medical treatment. An estimated sum of ₹1,20,000 to ₹1,50,000 is required for his treatment; out of this, her husband has deposited ₹40,000 at the hospital counter. Sabina Subba struck my husband with her vehicle, bearing Registration No. WB-74BM-2296. Sabina Subba's mobile number is 9531748053.

I earnestly request you to investigate this incident and take appropriate legal action against the alleged person.


