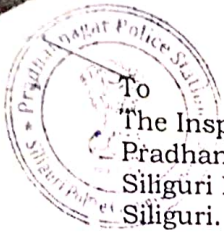

In producing herewith 01 (one) accused person namely Md Chhotu @ Tahir (34 yrs) S/O Lt Md Anwar of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) One (01) iron made improvised small fire arm measuring approx 23 cm in length including its 08 cm wooden pistol grip, having approx 12.5 cm barrel, trigger, firing pin and firing hammer in proper working condition - Marked as Exhibit "A" and (ii) 01 (one) live ammunition- Marked as Exhibit - "B". I, ASI Bikash Roy of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Md Chhotu @ Tahir (34 yrs) S/O Lt Md Anwar of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling to the effect that tonight i.e. on 04.04.26 at 00.30 hrs, I received a specific secret source information that one person is moving at Darjeeling More area under PS- Pradhan Nagar, Dist. Darjeeling with illegal fire arm with a view to sell the same to his designed customer or to commit any heinous crime at Darjeeling More area. Accordingly, I diarized the information in PS General diary vide Pradhan Nagar PS GDE No. 206 dated 04.04.26 and informed the fact to you. As per your kind order and direction myself along with ASI Prabal Sarkar, C/1119 Tanmoy Roy and force left for Darjeeling More with investigation kit to work out the information in hand by Govt. vehicle. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape. On the way to Darjeeling More, I requested night RT Van Officer SI Tinku Modak to come to Darjeeling More to accompany with us and also inform one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling over Mobile Phone and requested him to come to Darjeeling More with his camera for the purpose of videography if required. At around 00.40 hrs we arrived at Darjeeling More, I contacted with two independent person namely (i) Lalan Sha S/O Late Brojnath Sha of Siv Nagar Colony, Darjeeling More, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 9609880219) and (ii) Prakash Sha S/O Madan Sha of Durgaguri, Ward No-45, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 6294964189) and shared the information with them and requested them to remain present at the spot and act as witness during search and seizure if required upon which they agreed. In the mean time night RT van officer SI Tinku Modak came to the spot and accompanied with us. At 01.10 being pointed by the source, I noticed one person was standing near Hotel Tower Bangla, Darjeeling More. Accordingly, we cordoned the place every possible corner with due care and caution and managed to detain him. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. As per source information that the suspect possessed fire arm and ammunition, hence, immediately, I searched him and recovered the following articles viz - (i) One (01) iron made improvised small fire arm measuring approx 23 cm in length including its 08 cm wooden pistol grip, having approx 12.5 cm barrel, trigger, firing pin and firing hammer in proper working condition and (ii) 01 (one) live ammunition from his exclusive and conscious possession. On demand he failed to produce any document in respect of the fire Arm and ammunition which was found in his exclusive and conscious possession. On further interrogation he admitted his guilt and disclosed that he collected the said fire arm and ammunition from Bihar and came to Darjeeling More to hand over the same to his designed customer for his wrongful gain. Accordingly, I seized the above mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledge by the accused person.

Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, I then arrested him under proper memo of arrest and observing all the formalities for violating the norms of Arms Act. I informed him regarding grounds of his arrest and also issued copy of memo of arrest and ground of arrest to him.

The entire process of search seizure and label were made in between 01.25 hrs to 02.30 hrs on 04.04.26 at the spot under the coverage of videography executed by the above mentioned videographer as per norms of BNSS. Further I informed to the mother of the accused namely Helen Begam regarding arrest of Md Chhotu and also informed that the said accused will be forwarded before Ld ACJM, Siliguri on 04.04.26 morning.


Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Md Chhotu @ Tahir (34 yrs) S/O Lt Md Anwar of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling is desperate and dangerous in nature and he was carrying the said Fire arm and live ammunition with an objective to sell the same or to commit any heinous crime in the locality.

As he willfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Md Chhotu @ Tahir (34 yrs) S/O Lt Md Anwar of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling under proper section of law and its investigation may kindly be arranged.
