Sir,

In producing herewith three (03) accused persons namely (i) Md Sudha (19 yrs) S/O Sk Hafizuddin of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (ii) Md Kabrul (19 yrs) S/O Md Alam of Dharam Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, dist. Darjeeling and (iii) Sajrul Hossain @ Pale Khan (24 yrs) S/O Lt Kuddus Hossain of Gate Bazar near Sitala Mandir, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :- one sharp cutting weapon locally as Hasua measuring approx 25 inches in length including its wooden butt (ii) one sharp cutting weapon locally called as Hasua measuring approx 22 inches in length including its wooden butt (iii) one sharp cutting weapon locally called as Drigger measuring approx 16 inches in length including its wooden butt (iv) one idor made sabol measuring 21 inches in length and (v) one multi colour nylon bag. I, ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted three (03) arrested accused persons and others 07/08 unknown miscreants who involve in this crime, to the effect that on 04.04.26 at 01.35 hrs I received a specific source information that about 10/11 miscreants equipped deadly weapons assembled at Himachal Colony near a Rail Quarter under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Himachal Colony area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 207 dated 04.04.2026 and informed the matter to you. As per your kind order and direction, I along with ASI Anwar Abedin and force all of Pradhan Nagar PS, SPC left for Himachal Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT van officer SI Abir Dhar and requested him to come to Himachal Colony to accompany with us. On the way to Himachal Colony I informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling and requested him to come to Siliguri Junction with his camera for the purpose of videography if required.

At around 01.45 hrs we arrived at Himachal Colony under PS Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer SI Abir Dhar arrived there and accompanied with us. I shared the information with them and briefed them properly. Thereafter, I requested two independent witnesses namely (i) Apu Ghosh (38 yrs) S/O Manaranjan Ghosh of Subhash Pally, Ward No-19, PS- Siliguri, Dist. Darjeeling and (ii) Md Samim (44 yrs) s/O Md Kaum of Shantipara, PS- NJP, Dist. Jalpaiguri and shared the information with them and requested them to remain present at the spot and act as witness if any search and seizure would be made, upon which they agreed and expressed their willingness to co operate with me and act as independent witnesses. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that 10/11 persons were assembled near a Railway Quarter, Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehend above noted three (03) accused persons while 07/08 others unknown miscreants managed to flee away taking the advantage of open place and darkness.


Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence recovered from their joint possession which they kept concealed inside one multi color nylon bag. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 07/08 of their associates assembled there and were making preparations for committing Dacoity at Himachal Colony and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 02.45 hrs. to 03.10 hrs. at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed regarding ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS executed by the above mentioned videographer and brought all the three (03) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted three (03) accused persons along with 07/08 of their associates who fled away, gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Siliguri Junction. Later I informed their guardian regarding arrest of three accused persons and also informed them that all the three arrested accused persons will be forwarded before Ld ACJM, Siliguri on 04.04.26 morning at 10.00 hrs.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted three (03) arrested accused persons namely (i) Md Sudha (19 yrs) S/O Sk Hafizuddin of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (ii) Md Kabrul (19 yrs) S/O Md Alam of Dharam Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, dist. Darjeeling and (iii) Sajrul Hossain @ Pale Khan (24 yrs) S/O Lt Kuddus Hossain of Gate Bazar near Sitala Mandir, PS- Pradhan Nagar, Dist. Darjeeling and others 07/08 unknown miscreants who fled away from the spot and arranged for its investigation.
