Case

Sir, This is for your kind information that my mother
Smt Sabita Singh Basaily aged 60 years, and also the
Vice-Principal of Little Angel's School, Milan More,
Siliguri was hit by a bike rider on 01.04.2026 at
around 6.00 pm near B. R. Ambedkar Road,
Milan More, Siliguri. The biker ran away after
hitting her and leaving her seriously injured.
Now she has been admitted to Neotia
Hospital, Siliguri and had to undergo her
hip replacement surgery on 03.04.2026 and
still trying to recover from the trauma.

This is further to inform that the bike
rider was expected to seek an apology and
would compensate for the crime he has
committed. However, till date there is no
trace of him.

Under the circumstances, we are compelled to lodge a general diary against him for hitting and running away.

We would like to request you to kindly take the custody of the bike which is still ~~at~~ parked at B. R. Ambedkar Road. We would also like to hand over the keys in your office for your kind reference. It may be noted that the bike rider had even left the keys at the accident site itself.

We request you to kindly do the needful at the earliest.


