would like to report a serious incident of assault that  
occured today at 01:20 hrs (approx.)

On dt 04/04/2026, I was passing through Serok Road  
near payal cinema hall. At the time 01:20 hrs 8 to 10  
individuals, whom I can identify were unknown to me,  
stopped me. They were acting miscreants and one of them  
maliciously hit me on the head with a big stone.  
I sustained a serious head injury & consciousness.

I am in serious pain and some people help  
and immediate medical attention, I have attached my  
medical report from Shanti Substhalaya & Amundham Kendra  
Irt Ltd.

I request you to kindly register an FIR  
against these individuals under the relevant section of the  
Bharatya Nyaya Samhita (BNS) for voluntarily causing hurt/  
griveous hurt.
