Respected Sir,

I, SRI JITENDRA SAREEN, Son of Late Shyam Sunder Sareen, resident of Vaishnavi Apartment, 3rd Floor, Haiderpara, P.O. Haiderpara, P.S. Bhaktinagar, Dist. Jalpaiguri, in the State of West Bengal, at present point of time, I am one of the Advisory Committee Member of Food Corporation of India, Govt. of India and Bharatiya Janata Party Siliguri Dist. Committee District level designated Karyakarta, would like to draw your kind attention to the very effect that on every year I had been invited for Charak Puja festival at 10 houses colony near to Kali Temple of Ward No. 38 of Siliguri Municipal Corporation region wherein the house of my vehicle driver situated and accordingly, I had such invitation on 03-04-2026 wherein under compelling urgency, I failed to attend on the date fixed at the very evening. On the relevant day, my vehicle Driver namely Sankar Mandal Bike was out of service and at the very night, I advised him to use my four wheeler vehicle being Mahindra XUV 700 having registration No. WB73P5515 for going to his house and brought the same back on the next morning, accordingly my said driver left with the said vehicle and on being reached, he parked my said vehicle at road side. On the late night i.e. on 04-04-2026 at around 2.00 AM finding my said vehicle parked at road, under the leadership of 1) Lokenath Saha and 2) Poson Prasad along with more than 25 Trinamul Congress Party sponsored unknown goons who had come from out of our State, had assembled near to my said vehicle and called my said Driver under louder manner, when he came in front of them, said goons desperately asked "where is your Dada (Indicating me)" and on reply when my said Driver told that I was not there, then without spending any moment, they attacked my said driver with deadly weapons viz. iron rod, sharper objects, wooden stick etc and out of the said attack, my said driver received injuries at his head and the said goons with the aid of their deadly weapons, broke the front as well as side glasses of my said vehicle and also damaged too many other portions of my said vehicle. By breaking the vehicle glasses, they took cash worth of Rs. 43,000/- (Rupees Forty Three Thousand) only from the dash board of my said vehicle which I kept therein during on my last travel. It is right place to mention here that when my said driver shouted for help then the said Lokenath Saha aimed a fire arm over the chest of my said vehicle driver and threatened him with dire consequences if any short of shouting held by him. Thereafter, on receiving the said money from the said vehicle dash board, they left the place with further threatening of dire consequences and it is trite to be mention here that at that relevant moment due to being unavailable, my life had been saved, as I had political belief with BJP, I would be killed soon by them on any cost. It is right place to mention here that with an oblique motive to kill my said driver, the said TMC party sponsored goons under the leadership of said Lokenath Saha and Poson Prasad attempted such attack and my said driver received head as well as other bodily injuries and immediately after such incident immediately visited at Siliguri District Hospital. Moreover, the said goons under the leadership of said Lokenath Saha and Poson Prasad under conspiring and preplanned manner with an oblique motive to murder me, executed such plan under unlawfully assembled manner but I saved due to being unavailable at the said moment. On the other hand, my driver was subjected to physical assault in the way of attempt held with an extent to be murdered. There is every apprehension of further plan of execution to kill me and moreover, the said TMC party sponsored goons under the leadership of said Lokenath Saha and Poson Prasad brutally damaged my above referred vehicle and used to carry fire arms with them. It is right place to mention here that the said Lokenath Saha previously arrested for Arms Act charges wherein he attacked by firing upon to others. There is every possibility of ruthless attack upon me as such I am asking to take immediate action/s. Due to being panic stricken as well as looking for the care to the health of my said vehicle Driver, the delay held in filing the present complaint. The


