When I object that I will not allow him for second marriage they all started beating me and knocked my head on wall my husband tried to kill me by rapping dupatta over my neck, they throw me out of their house situated at Kholai bhaktri Tulsinagar, Bhutta khet. P.O & P.S. Matigara. I did not make any complain on the same date as my Pici sasuri Convinced me not to file any case and they will not give second marriage but now they all blocked my Phone Number and not allowing me to enter my house.


Therefore I request you to kindly Look into the Matter and take action against my husband and In-Laws and provide me justice from your end.
