Subject – Complaint against Tilak Sonar, Sachin Shankar, Priti Koirala, Puja Koirala, and Honeyasa Thapa- all are C/O Sunrise English Medium School, situated at Debidanga, Champasari, P.S. Pradhannagar, District: Darjeeling.

SIR,

With due respect, I, SMT. SHEETAL GUPTA SONAR, wife of Sri Tilak Sonar, and married daughter of Amichand Gupta, residing at Babubasha, Devidanga, Champasari, Siliguri – 734003, beg to submit the following facts and circumstances for your kind consideration and necessary legal action.

1. That I got married to Sri Tilak Sonar, son of Late Chandra Maya Sonar on 26.04 1999, at Pradhannagar, near Deokota Sang and thereafter we started to live together as husband and wife at Devidanga, Siliguri.
2. That out of our aforesaid wed lock a male child namely Trilok Sonar was born on 19.12.1999.
3. In or about June 1999, my husband and I decided to establish a small primary (play) school on a piece of land belonging to my father-in-law.
4. The said land already had a residential house constructed by my father-in-law in the name of my mother-in-law. On a portion of that land, we started a small pre-school with our limited resources and collective effort.
5. At that time, my husband was running a musical instrument shop at Chandra Mahal, Darjeeling Town.
6. The school, established in a remote area of Devidanga/Babubasha, was developed and expanded solely under my supervision and management. My husband used to visit the school on weekends and return to Darjeeling for his business every Monday.
7. In the year 2005, the school was registered as a society with the participation of family members and local residents.
8. Over the years, the school gradually expanded up to Classes VI, VII, and VIII.
9. Subsequently, my husband's musical instrument shop at Darjeeling was forcibly taken over by his elder brother, Sri Kiran Sonar, on the pretext of unemployment. Thereafter, my husband permanently shifted to Devidanga, and we began residing together. However, I continued to manage and nurture the school independently, without any assistance from him or others.
10. Later, we appointed Sri Sachin Shankar as the accountant of the school. After completing my M.A. and B.Ed., I was formally appointed as the

- Principal of Sunrise English Medium School in 2012, while my husband assumed the role of Director and Sri Sachin Shankar that of Secretary.
11. Gradually, Sri Sachin Shankar in collusion and connivance with my husband began exerting undue influence over all administrative and financial matters, reducing my role as Principal to that of a mere figurehead.
 12. In 2014, the school obtained temporary ICSE affiliation and was divided into Junior and Senior Wings. The Senior Wing was set up on Adivasi (ST) leasehold land for 30 years, while the Junior Wing was later gifted to my husband, Sri Tilak Sonar, by my mother-in-law, and stands upon undisputed raiyati land.
 13. Thereafter, serious differences arose between us. Both my husband and Sri Sachin Shankar began humiliating and intimidating me regularly, taking unilateral control over all school affairs and rendering my position untenable.
 14. In or around 2015, both of them informed me that the school had been "taken over" by one Sri Bimal Agarwal, who, according to them, had invested crores of rupees in the Senior Section. When I questioned them, my husband stated that we were now "employees" of the said person. I then demanded a salary and began receiving Rs. 18,500 per month from 2018 onwards, and Rs. 19,500 from 2019 onwards for my post as Principal.
 15. During the COVID-19 lockdown in 2020, my salary was irregular and, at times, completely withheld. Meanwhile, I continued to face severe humiliation and mental torture from abovenamed Tilak Sonar, Sachin Shankar, and staff members Smt. Priti Koirala, Smt. Puja Koirala, and Smt. Honeyasa Thapa. Under unbearable pressure, I was eventually compelled to resign in 2021.
 16. My husband, Sri Tilak Sonar, since inception of marriage has never provided me with household or medical expenses. He habitually insulted, humiliated, and abused me, both at home and in front of the staff at the school.
 17. Being an alcoholic, he often physically assaulted and verbally abused me under the influence of liquor. Finding it impossible to live in such conditions, I sought employment in Hyderabad in 2022, where I worked for about three months. However, I was compelled to return to Siliguri as my son was to travel abroad for higher studies.
 18. Upon my return, I discovered that my husband had moved to the upper floor of our new residence, isolating me to stay on the garage at ground floor. He restricted my movement, forbade me from going to the terrace or nearby temple, and repeatedly threatened to kill me.
 19. I have been continuously subjected to mental cruelty, verbal abuse, humiliation, and psychological trauma, to the extent that I now live in constant fear and depression.
 20. Being the only non-Nepali member of the school management, during my tenure in the school, I was discriminated against and repeatedly humiliated by Priti Koirala, Puja Koirala, and Honeyasa Thapa abovenamed with

consent of my husband . I was also deliberately excluded from financial decisions and denied access to school records and data, in spite of being a life member of the society.

21. All meetings of the school management were sham and merely on paper. Several school documents contain forged signatures, including mine. My husband, Sri Tilak Sonar, under the active supervision of Sri Sachin Shankar, has forged my signature on multiple school documents and official records.
22. Further, Sri Tilak Sonar fabricated an authorisation letter for vehicle use in my name using forged signatures, without my consent or knowledge.
23. The above-named staff members, namely, Smt. Priti Koirala, Smt. Puja Koirala, and Smt. Honeyasa Thapa, routinely insulted, ridiculed, and mentally tortured me, acting in concert with Tilak Sonar and Sachin Shankar inside the school premises.
24. At present, I live in constant fear for my safety. Tilak Sonar has even attempted to harm me through tantrik (black magic) means and frequently declares that I am not his wife and have no legal right over either the school or the matrimonial house.
25. Recently, I came to know that Tilak Sonar has secretly re-established contact with his ex-wife without my knowledge or consent; a clear indication of his malicious and deceitful conduct.
26. Since the year 2019, Mr. Tilak Sonar, has made several foreign trips, misappropriating school's fund and thus endangering the operations and eventual reputation of the school.
27. That presently all the aforesaid persons specially since the year 2024, are constantly threatening to harm me in life and limb in the event I approach before any lawful authority against their unlawful acts and conducts. Their constant verbal threats has forced me to stay outside my marital house due to fear of life.

Therefore, I request you to kindly take strict legal action against above named Tilak Sunar, Sachin Shankar, Priti Koirala, Puja Koirala, and Honeyasa Thapa ands ensure proper justice to me.
