withdrawal of money through ATM card.

This is to inform you that from my savings account
(mentioned above) an amount of Rs 25000 (approximately)
has been debited/withdrawn today in between 12 noon
to 1:00 pm through multiple transactions.

In the morning at around 11:30 am, I deposited an
amount of Rs 34,500 (cash) through ATM of Punjab
National Bank located at Hill Cart Road. While

my hand. A service staff who was present inside the
