Subject – Written Complaint

Sir,

I **SMT. SANCHITA BISWAS**, Wife of Dolon Biswas, Presently residing at 50, Balaidas Chatterjee Road, near Arunaday Sangha Club, Hakimpura, Post Office – Siliguri, Police Station – Siliguri, Dist Darjeeling, Pin – 734001, do hereby lodge this written complaint on the following effects with the request for taking immediate action against the Driver of the four wheeler bearing No. WB74AB1821.

1. That on 05.04.2026 at about 4:15 PM my husband was going towards house from the hospital road. My husband was walking from the left side of the hospital road but suddenly one four wheeler (wagner) sky blue Colour bearing No. WB74AB1821 hit my husband from the back, my husband lost control and fell on the road, after seeing the incident people gathered the driver of the four wheeler (wagner) was trying to escape but the traffic police and

the other local people resist the vehicle. After the such accident the traffic police and other public rush towards my husband and he was badly injured, he got several injury in his hand, back and in different parts of his body, even his nose was bleeding. Immediately he was taken to Siliguri Hospital by the local people and it was continuously bleeding after all the examination and procedure done by the emergency Doctor it came to know from the Doctor that his nose was broken. He was such in a pathetic condition, subsequently he was taken to Basu Clinic Nursing home, Siliguri and still my husband is admitted in Basu Clinic doctor and still he is admitted in Basu Clinic Nursing Home, Siliguri advice of Doctor, it requires immediate operation to save life of my husband.

I further state that yesterday he was in ICU and he was not able to talk properly but unfortunately today when I visit my husband he narrated me the entire sinario what actually happened to him. I emphatically state that my husband was walking on the left side of the road but the driver of the four wheeler (Wagner) bearing No. WB74AB1821 was not in normal speed, it was rush and negligence from the part of the driver of the four wheeler.

Sir, I pray before your office that the driver of the four wheeler bearing No. WB74AB1821 was driving the vehicle in a rush and negligent way, which is not only an unwarranted action but preceeded too and the driver of the four wheeler has committed the offences and liable to be prosecuted under the penal provision of law Act and as such I do request to start specific criminal case against noted driver of the four wheeler bearing No. WB74AB1821 and to arrest them immediately to ensure justice.

It need to be disclosed that all the medical papers and documents are lying with the custody of the Basu Clinic Nursing Home, Siliguri and I also do request to procure the required documents to ensure justice from Nursing Home.
