
Respected Sir,

I, SI Nirmal Kr. Das, presently posted as Officer-In-Charge, Panitanki Town Out Post under your kind control, do hereby lodge this written complaint against Sri Shankar Ghosh, Amit Agarwal, Jayashree Modak, Tanushree Modak, Koushik Sarkar, Yogesh Garg and other 20-25 supporters of "BJP" Party to the effect that on 05.04.2026 an information was received regarding destruction and torn of flag of TMC Party as well as distorting TMC Candidate's banner with stickers of BJP Party leaders on the face of the image of the contesting TMC candidate and it was diarized vide Panitanki TOP GDE No.126 Date: 05.04.2026. S.I Prakash Ch. Sarkar was endorsed to enquire the matter accordingly he also took up its enquiry. During enquiry S.I Prakash Ch. Sarkar collected some information and on 06.04.2026 at 12.45 hrs I along with other Police personnel namely SI Shib Sankar Das, S.I Prakash Ch. Sarkar, ASI Surojit Mallick, ASI Debasish Das, LC/575 Panchami Roy went to Punjabi Para W/No.13, P.S- Siliguri, Dist- Darjeeling to verify the veracity of information which was diarized vide Panitanki TOP GDE No.149 Date: 06.04.2026.

During enquiry it could be learnt that few members of local BJP Party and their associates namely Amit Agarwal, Jayashree Modak and Tanushree Modak are may be involved in this incident. Hence, I along with others police personnel went to the Shop of Amit Agarwal to verify the information but in vain as he was not available in his shop. Thereafter we had been to Punjabipara, in the house of Jayashree Modak and Tanushree Modak and met with them. While our enquiry almost completed in presence of Lady Constable and about to return suddenly 20-25 supporters of BJP Party under the leadership of Sri Shankar Ghosh, unlawfully assembled on the spot and intervened in our enquiry. Then I asked them to let us to discharge our duty as well as to maintain law and order but they continuously threading us with loudly voice and repeatedly stating that "আমরা আপনাদের তদন্ত করতে দেব না আপনি যা পারেন করে নেন। আর মনে রাখবেন আগামি চার তারিখের পর আমরা সরকার চালাব তখন আপনাদের কি হাল করে ছাড়ব ভাবতে পারবেন না।" Then we understanding the heed of the situation, intending to return back to Panitanki TOP in our Govt. vehicles, but the said Shankar Ghosh suddenly pushed me from my chest and threatened me & other police personnel and wrongfully restrained to our road to return. However, we somehow managed to leave the place. Later on, said Sri Shankar Ghosh along with his associates came in front of Panitanki TOP and stared unlawfully assembled and was creating obstruction in the public place & blocked the main gate of Panitanki Town Out Post for few hours.


Over these facts and circumstances, I pray before you to kindly initiate a specific case against Sri Shankar Ghosh, Amit Agarwal, Jayashree Modak, Tanushree Modak, Koushik Sarkar, Yogesh Garg and other 20-25 supporters of "BJP" Party for unlawfully assembled, obstruction of Public Servant in discharge his official duty, disobedience to order duly promulgated by public servant, threat of injury to public servant, restraining and disobeying the direction of public servant and also using ill-wards to the Police personnel and kindly arrange for it's investigation.
