Sub: - Prayer for lodging F.I.R.

Sir,

With due respect and humble submission, I SI Ramanath Karjee of Gajaldoba Out Post under Bhorer Alo PS do hereby lodge this complaint against the unknown persons to the effect that on 27.03.2026 at about 14:25 hrs while performing mobile van duty along with force in Gate Bazar area vide Gajaldoba OP MCC No. 492/26 dated. 27.03.2026, it came to my notice that a Ram Navami procession was approaching Gate Bazar from the direction of Ambari Falakata.

During the said procession, I noticed that a large number of devotees including male, female and youngsters took part in this festival but it is surprising to see that several numbers of unknown persons majority of them were youths raising sword in their hand which created an atmosphere of fear among the devotees Accordingly, considering the fact and without wasting time I along with force immediately intervened and started to trace out the persons who created an atmosphere of fear among the devotees by shouting and raising swords in their hand but large number of gathering made us impossible to trace out the persons and by taking advantage of crowd they escaped from the place. Further, the procession was accompanied by loud DJ sound systems, which were being played in violation of existing legal restrictions.

It is pertinent to mention that as per the directions and orders of the Hon'ble High Court, Calcutta the use of DJ sound systems and such loud music in public processions has been strictly prohibited/restricted. The act of organizing such a procession in defiance of the said order amounts to clear violation of lawful authority and disturbance of public peace.

Therefore, this complaint is being lodged for taking necessary legal action against the offenders under relevant sections of law.
