Subject: Complaint regarding rash and negligent driving by dumper causing grievous injury and damage to vehicle.

Sir,

I, Neelam Biswakarma, wife of Satyen Gajmer, most respectfully submit as follows:

That on 27.03.2026 at about 10:45 PM, my husband Satyen Gajmer, son of Late Lalit Gajmer, resident of Shastri Nagar, Ward No. 41, P.S. Bhaktinagar, Jalpaiguri – 734001, along with Sanjay Gajmer, son of Late Lalit Gajmer, resident of the same address, were travelling in a vehicle bearing registration no. WB-74V-8701. The said vehicle is owned by Wangyel Yonzon, son of Late Indra Bahadur Yonzon, resident of Kurseong, Post Office Kurseong, District Darjeeling – 734203, and was being driven by Sanjay Gajmer.

That I was informed about the said accident through a telephone call made by Sanjay Gajmer shortly after the occurrence of the incident.

That while they were proceeding from Jalpaiguri and reached near Nouyapara Traffic More, a dumper bearing registration no. WB-73M-1786 came from Fulbari side (Canal Road) at a very high speed and in a rash and negligent manner and violently dashed against their vehicle.

That due to the said accident, both my husband and Sanjay Gajmer sustained grievous injuries and were immediately shifted to Ramkrishna Seva Sadan, Bidhan Road, opposite Hotel Dolly, Siliguri, where they are presently under treatment. The said vehicle has also been extensively damaged.

That the accident occurred solely due to the rash and negligent driving of the dumper driver, who drove the vehicle without due care and caution, thereby endangering human life and property.

I therefore request you to kindly register an FIR, conduct a thorough investigation, seize the offending dumper vehicle bearing registration no. WB-73M-1786, and take strict legal action against the driver and owner of the said vehicle in accordance with law.

I am ready to cooperate with the investigation and shall produce all relevant documents including medical records and vehicle documents as and when required.
