**Subject:** Complaint regarding damage to WBSEDCL electrical infrastructure due to vehicle collision

Sir,


I beg to inform you that the undersigned came to know from the supervisor of the night mobile van of Fulbarihat CCC, WBSEDCL, that on 31.03.2026 at about 01:00 AM, a vehicle bearing registration number WB73-M-6422 struck a transformer substation at Balaram, near Kanchanjanga Rice Mill.

Due to the said incident, significant damage was caused to WBSEDCL electrical infrastructure, including two (02) transformers. The approximate loss of WBSEDCL property is estimated to be around ₹70,000/- (Rupees Seventy Thousand only).

In this regard, you are kindly requested to take necessary action as per law against the concerned vehicle.
