Sir,

In producing herewith 01 (one) arrested accused person named Sabananda Barman (M/33 years) S/o-Naresh Barman of vill-Kamatpara, Farabari, PO-Sahudangi Hat, PS-Bhorer Alo, Dist. Jalpaiguri under arrest along with following articles under proper seizure-

- (i) 10 (Ten) bottles of Mc Dowell's No. 1 Luxury whiskey each bottle contains 180 ML total (10 x 180) = 1800 ML/1.8 L which was kept in a plastic made bag, each bottle's price = Rs. 200/- (Total price=10 x 200 = Rs. 2000/-)
- (ii) 01 (one) white coloured plastic made bag.

I, ASI Sk. Tinku, S/o-Lt. Sk. Ajajul of Bhorer Alo Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person named Sabananda Barman (M/33 years) S/o-Naresh Barman of vill-Kamatpara, Farabari, PO-Sahudangi Hat, PS-Bhorer Alo, Dist. Jalpaiguri to the effect that today on 03/04/2026 at 21.05 hrs while performing my K-39 (II) evening mobile van night duty I received a specific source information that one person is selling liquor in a street shop at Ambari Road under Bhorer Alo Police Station without any valid license. Accordingly, I informed the matter to the O/C Bhorer Alo Police Station PS and diarized the fact in General Diary vide Bhorer Alo Police Station PS GDE No. 137, dated 03/04/2026.

As per your kind order and direction, I along with SI Chiranjit Saha, C/1489 Samir Barman and C/1492 Partha Chakraborty all of Bhorer Alo PS left for Ambari Road under Bhorer Alo Police Station to verify the veracity of source information. On reaching there and as identified by the source I along with other officer and force conducted raid at Ambari Road under Bhorer Alo Police Station and managed to apprehend him. On being asked he disclosed his identity as noted above and also disclosed that he is storing illicit liquor illegally at his street shop to sale the same in higher price for his wrongful gain. On being search the above noted articles were found from his conscious and exclusive possession. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Then, I seized the above mentioned illegal illicit distilled liquor under proper seizure list from his possession and subsequently, arrested the above mentioned detained person Sabananda Barman (M/33 years) S/o-Naresh Barman of vill-Kamatpara, Farabari, PO-Sahudangi Hat, PS-Bhorer Alo, Dist. Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 21.55 hrs to 22.15 hrs at the spot for violating the norms of Bengal Excise Act. The whole process of seizure is video-graphed. The ground of arrest has been duly communicated with him.

I, therefore pray before your good self that a specific case may kindly be initiated against accused named Sabananda Barman (M/33 years) S/o-Naresh Barman of vill-Kamatpara, Farabari, PO-Sahudangi Hat, PS-Bhorer Alo, Dist. Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
