I told him the O.T.P. Then he asked me for another phone and started video calling me. As he convinced me that he is a real person so I did whatever he told me to do. On 04/04/26 when I wanted to withdraw money from my account, I found that only Rs 1200/- was left in my bank account. That person cheated me and withdraw total of Rs 7,12,022.24 from my bank account.
