Respected Sir,

I Dr. Kritee Adhikary, d/o Shri Kanchan Adhikary, resident of Sumati, Pratima Bandopadhyay Sarani, near 4H club, Deshbandhupara P.S. - Siliguri, District- Darjeeling, 734004, beg to state that, today, while returning from Jalpaiguri, by my vehicle, **WB 02 AH 0743**, Red WagonR, I took a turn at crossing of Jalpai more at round 2:10 pm , 07.04.26 , and while taking the lane, a "White Innova" with vehicle no." **WB 76 6680**" the vehicle rashly shove through the right side of my car, near "Siddheshwari kalibari, SF road" and stalked me my car upto "Fire brigade SF road" stopped and he grabbed my the collar of my Father Shri Kanchan Adhikary and outraged the modesty of my mother Smt. Anushree Adhikary. They started blaming and cussing my father for letting me drive the car , assuming me a novice, me being a young lady and started cussing me. The driver of the Innova Car gathered a mob, and was going to start opening the tyres, and they stoned to the windshield of my Car and broke rearview mirror of left side of the car . Then they dragged my brother Krititwa Adhikary to the ground and beat him blue and black, injuring my brother's waist, lower back, knee and elbow. Broke my brother's spectacles and was going to blow his nose. When I jumped into his rescue, they laid me flat on the ground and started beating. They started grabbing each one of us turn by turn , they sprained my mother's finger , punched her nose and it started running . They were not letting us get into the car , confined us , threatened us that they will "Cut us into pieces, Teesta Syndicate won't let us go , if we don't pay a compensation".

An on-duty police officer came to our rescue and lastly another traffic police drove us safely to the Siliguri police station .
