Respected Sir,

I, **SMT RENU SHARMA**, Wife of Satish Kumar Sharma, resident of Naya Bazaar, Khalpara, Ward No. 8 of S.M.C., P.S. Siliguri, Dist. Darjeeling, in the State of West Bengal, would like to draw your kind attention to the very effect that today i.e. on 07-04-2026 at around 4.00 PM I went to book Gas at **Sri Narayani Gas Agency**, Situated beside Vishal Mega Mart, Ward No. 5 of S.M.C., on my visit and query about the gas booking, the attending staffs of the Gas agency started misbehaving with me and uttered threatening as well as abusive languages to me which raised panic upon me and I started crying, thereafter finding no other alternative, I called my son namely Gourav Kumar Sharma over phone and when he arrived and raised his concerns about the misbehaviour upon me and also asked about the gas booking irregularities concern as our family is suffering about the gas service from the agency, the said Narayani Gas Agency attending officials along with 3-4 outsider miscreants under the leadership of owner **Nabin Choudhury**, 10 Staffs including **Bikky Choudhury** physically assaulted me and my son and also outraged my modesty by pulling my wearing apparels, they forcibly ousted me and my son from the office and thereafter threatened us with dire consequences if We further raise any concern about the gas booking irregularities in any future event. Out of the said attack, I along with my son sustained bodily injuries and under immediate effect. We had been medically treated at Siliguri District Hospital and right now We are living in fear of being further attacked if asked for our consumer rights to get gas service from the said Narayani Gas Agency. The black marketing of Gas is in it's pick at our region and the said Narayani Gas Agency with the aid of antisocial in their office, are spreading panic towards the consumers with their desperate/gunda attitudes, by which the agency trying to shut the voice of the consumers. It is high time to take drastic action/s against the very agency along with it's said owner Nabin Choudhury and other 3-4 outsourced miscreants.

I am, therefore, requesting you to take appropriate legal action/s against the above-named Narayani Gas Agency and it's attending gunda officials for the proper administration of justice.
