**Sub: Written complaint against Sourav Basu Sarkar and four others for life-threatening rash driving, criminal intimidation, and criminal conspiracy.**

Sir,

I, Niraj Kumar Sah, S/o Sri Shivnath Sah, resident of Ganganagar, Ward No. 5, P.O- Siliguri Bazar, P.S- Siliguri, Dist- Darjeeling, would like to lodge this formal complaint against Sourav Basu Sarkar and four other associates. On 07-04-2026, at approximately 10:50 P.M., while I was riding my motorcycle at the Jhankar More Traffic point towards my home, a white Bolero being driven in an extremely rash and negligent deliberately crashed into my bike. The impact was so violent that I was thrown onto the road and lost consciousness for some time. Upon regaining senses with the help of local bystanders, I saw Sourav Basu Sarkar and four others coming outside from the vehicle. They were in a heavily intoxicated state, with a strong smell of alcohol coming from them. Instead of providing medical aid, they surrounded me and began abusing me and criminal intimidating, threatening me with dire consequences if I reported the matter, claiming they have "high-level political sources". As soon as a police van approached the spot, the accused persons fled the scene. I was subsequently rescued by a friend who moved me to Siliguri Hospital for emergency medical treatment. Following my return home, the primary accused, Sourav Basu Sarkar, contacted me via phone and gave me threat to my life and my family, identifying himself as the President of BJYM and his political power. He explicitly threatened to frame me and my family members in false criminal cases to ensure we "rot in jail" if I pursued legal action. This entire sequence of events indicates a clear intent to cause grievous hurt.

Therefore, I earnestly request you to register an FIR against Sourav Basu Sarkar and his associates under the relevant sections of the law for drunk driving, causing hurt by endangering life, and criminal intimidation, and to take immediate necessary action to ensure my safety.
