In producing herewith three Bangladeshi National namely i) Azam Ali @ Mohamad Azam Ali (M- 37 years) , S/o Mahammad Cattar Ali of 149 Akhil Monzil, Annasarapalia, A.S.P.H Hostel Road, Bengaluru, Karnataka having Indian PP no. Y7249677 valid upto 08/08/2033 Bangladeshi Address: Vill- Matherganj, PS Vulli, Dist Thakurgeon, Bangladesh . 2) Rima Akter (F-29), W/o Azam Ali of 427/2 Alfa Manzil 1st Flr 1st Cross Syed Block, Annasandrapalya, Bengaluru, Karnataka having India PP no. C1447701 valid upto 22/08/2034. During immigration clearance it was notice that the above subjects are originally a Bangladeshi National (by birth).

On questioning the above persons admitted that they are originally Bangladeshi nationals. They had lastly entered India on 10.12.2016 on the strength of their Bangladeshi passport no. BC0270143, BB0776583 & BM0151641, respectively. On further questioning Azam Ali claimed that, after entry into India they travelled to Bengaluru and stayed at a rented accommodation located at Dassr Halli, P.S Pina 2nd Stage, Dist- Bengaluru, State- Karnataka. Present add:- C/o Md. Akhil, of 252/2 Akhil Manjil, Anna Chandra Pallya, 1st Cross Vimanpura, A.S.P.A Hostel Road, P.S Hindustan Aeronautics Limited (H.A.L), Dist: Bengaluru, Karnataka staying in this address since last 07 years. He is engaged in working as a Health Facilitator Service at Apollo Hospital, Bengaluru and earned about Rs 25,000- Rs 30,000 per month. They claimed that they had managed to procure the following Indian IDs with the help of one BD national namely one Amirul Islam.
