Respected Sir I Tarannum parveen D/O Habibullah Sheikh residing near NBMCH Siliguri. I would like to bring in your kind knowledge that on 5/4/2026 at around 2 am. my sis Subnum parveen W/O SK Samjad Ali presently residing at Josephakhuri NJP heard the noise of banging of door ~~or~~ so & got up from deep sleep and went towards the door. She saw 6,7 persons has already broken the door and entered in the house in disguise manner. As she was about to scream suddenly one person grabbed her mouth and suffocated her so that she could not make any noise. Another 2,3, person held her both hands tightly, and one person try to slit ~~with~~ her neck using sharp knife. She tried her best to defend herself and in the meanwhile she realised that the one who grabbed her neck was ~~her~~ father [1] HABIBULLAH SHEIKH S/O Sikander Ali. The one who tried to slit her neck was [2] RAHUL KUMAR S/O Dayanand Prasad Singh. The one who was hitting on her head and chest was [3] RANJIT SRIVASTAVA S/O Sri Ganesh Prasad hit her with fist and blows and broke ~~her~~ tooth. They pushed ~~to~~ her on the floor but did not spare her mouth so that ~~she~~ she can't shout loudly and ask for help. As they started disrobing her she vigorously moved her hands and legs to protect herself. By that time she saw several deep cuts on her chest shoulders and back which was bleeding. She saw her ~~our~~ step-mother [4] SHAHNAZ RAATOON n.

Habibullah Sheikh and [5] SHAMA PARYEEN w/o Subhanulla
ran running towards her son whispering that they will
kill them by poisoning. [6] SK SAMJAD ALI s/o SK Sikand
ari along with all five accused forcefully administ
ered poisoning her orally. Even her son who is a mine
rately Zahin Sheikh aged 11 years started shouting for
help so two person's went to her son and grabbed his
neck and suffocated him. But fortunately these accused
heard some people passing by making loud noise of
possep so all the accused got alert and rushed to flee.
While fleeing they stole her two very important file
containing original ~~files~~ documents including my
medical documents, land agreements, Original Hibnam
agreement of land of mine, medical report of her
miscarriage of female foetus etc while ~~was~~, death
certificate her girl child etc. While when they were
rushing out they spotted the CCTV camera installed
in her house and ~~case~~ snatched the camera to remove
~~the~~ tamper evidence. In this rush my father left on
of his slipper and the bottle of poison (paraquat dichlor
24% SL).

She has filed several complaints against these accused
that they want to kill her for the sake of money, power &
property. [7] MD KHAZILULLAH SHEIKH s/o Habibullah Shei
is also a mastermind behind all these conspiracy because
has given huge bribe around 1.70 crore for his NEET I
Seat in 2026 and want to sell all our ancestral proper
and deceased mother's property to pay back his bribe
amount as she is the biggest ~~to~~ hindrance for all th
accused's illegal motives.

Sir please take necessary and immediate actions and
punish them as per BNS of law.
