In producing herewith four (04) accused persons namely 1) Partha Roy (24 yrs./M), S/O-Sanjit Roy of Gokulvita, Ambari, PS Bhorer Alo, Dist Jalpaiguri 2) Md. Rustam @ D (22 yrs./M), s/o Md. Ashlam of Rajaholi, PS New Jalpaiguri Dist Jalpaiguri 3) Tinku Bhuiya (22 yrs./M), s/o Sankar Bhuiya of South Colony, Masdoor Basti, PS- New Jalpaiguri, Dist- Jalpaiguri and 4) Manik Biswas (23 yrs./M), s/o Rabi Biswas of Shantipara, Madhav Mandir, PS New Jalpaiguri Dist Jalpaiguri along with seized articles via:-

1. One iron made sword approx length 03 (Three) feet along with wooden handle.
2. One iron made Axe approx length 02 (Two) feet along with bamboo handle
3. One iron made Hammer approx length 01 (one) feet. along with bamboo handle
4. One electric torch light
5. One blue colour Nylon rope.

I ASI Nilam Swarnakar of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 10/12 persons to the effect that on the night 07/04/2026 at 00-05 hrs received secret source of information to the effect that some miscreants with deadly weapons assembled in a dark place at Kashmir Colony Ucha Math under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 351 dt. 07/04/2026. As per your kind direction at 00-10 hrs myself along with C/1462 Sajan Tamang, C/453 Uttam Dey, VP-13 Jamirul Islam VP 08 Laxman Roy, CV - 306 Biswajit Roy left from PS for Kashmir Colony Ucha Math to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 00-15 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the Kashmir Colony Ucha Math under NJP PS, found a group of 10/12 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the above noted four (04) persons and the others 06/08 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Kashmir Colony Ucha Math under NJP PS. Thereafter all the apprehended persons were searched and in presence of independent witness I conducted search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in video graph as per provision of law. Accordingly I arrested the above noted accused persons u/s 35 BNSS after informing the ground of arrest and dully issue of memo of arrest. The whole seizure was made between 00-45 hrs to 01-25 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against 1) Partha Roy (24 yrs./M), S/O-Sanjit Roy of Gokulvita, Ambari, PS Bhorer Alo, Dist Jalpaiguri 2) Md. Rustam @ D (22 yrs./M), s/o Md. Ashlam of Rajaholi, PS New Jalpaiguri Dist Jalpaiguri 3) Tinku Bhuiya (22 yrs./M), s/o Sankar Bhuiya of South Colony, Masdoor Basti, PS- New Jalpaiguri, Dist- Jalpaiguri and 4) Manik Biswas (23 yrs./M), s/o Rabi Biswas of Shantipara, Madhav Mandir, PS New Jalpaiguri Dist Jalpaiguri and other 06/08 persons and arranged for its investigation.
