Sir,

With due respect I, Miss Anindita Chakraborty, Daughter of Late Arun Chakraborty, resident of Sitala Para, (Natun Para), Road No. 9, Siliguri, Pin-734005, Dist. Jalpaiguri beg to lodge this information to your end that today at about 2.00 P.M. when I was in Siliguri Court for my profession, my mother called me over Cell phone stating that my full blooded uncle viz. Amit Chkraborty, Son of Late Anil Chakraborty, resident of Sodepur, Kolkata who came to his house alongwith his wife and daughter on 31.03.2026 which is situated in the same premises as the said property is ancestral Property of our predecessor. My said uncle taken loan few lacs of Rupees in Cash from my mother time to time some times back. On seeing my said uncle, my mother requested my uncle to return back at least Rupees Ten thousand only for her operation as advising by the Doctor to my mother from some time back as my mother has been suffering from high blood pressure, high sugar and other various ailments. On hearing that my said uncle alongwith his wife, his mother in law viz. Shila/Seuli Ghosh and his brother in law viz. Bhola Ghosh became very furious and physically assaulted my mother and due to that my mother fallen on the cemented floor and she is suffering from severe pain in her body.

Thereafter they also physically assaulted my youngest sister with feast and blows. My said sister is a physically challenged patient. Due to said assault and torture made by my said uncle and his wife, his mother in law viz. Shila/Seuli Ghosh and his brother in law viz. Bhola Ghosh, my sister become seriously ill with severe pain in her body.

After getting the call from my mother about such incident I then and there rushed to our house from the Siliguri Court when my uncle saw me to come in front of our house then and there my said uncle, his wife, his mother in law viz. Shila/Seuli Ghosh and his brother in law viz. Bhola Ghosh rushed in front of our house and my uncle physically assault me with feast and blows and molested me on the Road and also tried to pull my shirt and tearing it by his own hand in public place and pushed my throat by my uncle and his wife using filthy languages abused me towards my legal profession and abovenamed Bhola Ghosh who came with an iron stick and handed over the said stick to my uncle who ran towards me to and shouted that I will kill you , when I managed to fled away at that time.

Thereafter my uncle , his wife and his brother in law removed my mother and my said sister from our house and took the key of our house after locking the main door of the house.

I, further let you inform that my said uncle, his wife, his mother in law viz. Shila/Seuli Ghosh and his brother-in-law did the almost same illegal offences upon my another Aunt viz. Gouri Chakraborty who is an widow in the morning yesterday.

Now, my said uncle, his wife and their associates shouting saying that our entire ancestral property is none but his alone and he shall forcibly evict us as well as other legal heirs of our grand mother viz. Manjuri Chakraborty , since deceased. All the documents relates to the said property which stands in the name of our grand mother viz. Manjuri Chakraborty have snatched by my said uncle from my late father Arun Chakraborty years together back and kept with him for practicing fraud upon us.

Since, I myself my ailing mother and my physically challenged sister residing in our house alone and due to such illegal act by my said uncle, his wife, his mother in law viz. Shely /Seuli Ghosh and his brother in law viz. Bhola Ghosh we are in deep fear that at any moment of time the said accused persons may murder us unless to protect us and take appropriate legal actions against them without any delay putting them in iron bar.

I, therefore, lodge this First information report to your end to arrest the accused persons named above immediately and get opened of our house without any delay so that we can stay in our house safely and prosecute the accused persons keeping them in iron bar.
