Due to his bad behaviour towards me, I stopped interacting with him for a few months. Later in July, 2025 again he started to interact with me on my WhatsApp as well as in my Facebook Messenger. I met with him at kolkata too in the year of 2025. I started to believe and trust him. Suddenly he requested me to provide Rs. 20,000/- for purchasing Cell phone and I transferred the said amount online on 26-01-2026. Thereafter I was surprised by his behaviour towards me and I came to know that he started to post my photograph after tampering and sending it to my parents, brother and other close relatives and friends. He continuously started to malign me by posting ugly and vulgar words, photographs. after creating a Fake Facebook account in the name of Raj Roy he is doing illegal work. I started to interact with him as my one good friend as I believe and trust him. Several times I requested him not to malign me before the eyes of the society, but in vain and I blocked him.
