In producing herewith five arrested accused persons namely (1) Miss Puja Rasaily (33), D/o- Ranju Rasaily of Shastri Nagar, near Shib Mangal School, W/No. 41, PS- Bhaktinagar, Dist- Jalpaiguri, (2) Azharuddin Sha (39), S/o- Md. Safique of Gurung Busty, Upper Road near Old Loyola School, W/No. 3, PS- Pradhan nagar, Dist- Darjeeling, (3) Pappu Giri (48), S/o- Shyam Narayan Giri of Porsupur, PO- Rasepur, PS- Tarwa, Dist- Ajamgarh (U.P.), (4) Samse Alam (35), S/o- Moti Rahaman of Dipnagar, Jamai Bazar, PS- Pradhan nagar, Dist- Darjeeling and (5) Md. Murad Ansari (40), S/o- Abdul Latif of Prakash Nagar, near Kali Mandir, W/No. 43, PS- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles under seizure as per seizure list:

- iv) One Apple I-Phone 14 Pro having IMEI No. 354542508547612 and SIM No. 9434686284 (Airtel) from the Possession of Samse Alam.
- v) One Samsung phone having IMEI No. 350115575461787 and one Apple I-Phone having IMEI No. 353037113920560 from the possession of Pappu Giri.
- vi) One black colour Realme mobile phone having IMEI No. 860605064364172 and SIM No. 7477846345 (Airtel) from the possession of Azharuddin Sha.
- vii) One black colour Apple I-Phone having IMEI No. 3535854656464456 and SIM No. 9933387786 (Airtel) and one One Plus phone mat sky blue having IMEI No. 867268074724498 from the possession of Md. Murad Ansari.
- viii) One Vivo ~~17~~ white steel colour phone having IMEI No. 862027048741136 and SIM No. 9749163081 (Jio) from the possession of Puja Rasaily.

I, SI Anup Kumar Das of Siliguri Police Station, SPC do here by lodge this written complaint against the above noted persons to the effect that on today i.e. 08.04.2026 at about 16.05 hrs. I received a specific source input that few persons are coming in a small vehicle having Registration No. WB 74 BK 7291 towards Eastern Bypass through South Bharat Nagar, Jorapani bridge with a huge consignment of Brown Sugar for supplying the said consignment to their designed customers for their wrongful gain. The matter was diarized vide Siliguri P.S. GDE No-486, Date- 08.04.2026. Accordingly, I informed the matter to the I/C, Siliguri PS and also inform to Shri Somnath Das, WBPS, ACP, East-I, SPC in writing and expressed the entire information. As per his kind direction at about 16.25 hrs, myself along with ASI Debasish Das, ASI Rabin Lama, ASI Minhaj Al Kader, C/160 Soumen Sarkar, LC/1267 Shashika Rai all of Siliguri Police Station, SPC and along with one vedigrapher namely Ganesh Paswan, S/o Nathu Paswan of Vivekananda Road, Khalpara, W/No.07, PS Siliguri, Dist Darjeeling left for South Bharat Nagar near Jorapani Bridge under Siliguri PS by Govt. vehicle with investigation kit to verify the veracity of the information vide Siliguri PS P.S. M.C.C. No- 155/26, dated- 08.04.2026. This refers to Siliguri P.S. GDE No- 488 dated- 08.04.2026.

At the time of departure from the Police station, I sent an e-mail to SDO, Siliguri to depute an Executive Magistrate to supervise the process of search and seizure if any. At about 16.35 hrs we arrived at South Bharat Nagar near Jorapani bridge under Siliguri PS. Then I met with the source and share about

the information in nut shell. I also called the van officer ASI Barun Kumar Dey to accompany us. In the mean while, I called two independent witnesses namely (1) Tamal Sutradhar (38), S/o- Dulal Sutradhar of South Bharat Nagar, near Jorapani Bridge, W/No. 24, PS- Siliguri, Dist- Darjeeling and (2) Litan Mandal (50), S/o- Lt. Sanket Mandal of Subhashpally, near Netajee Boys School, W/No. 20, PS- Siliguri, Dist- Darjeeling who were present there and disclosed our identity and informed them in writing letter about the information in hand and requested them to accompany us in the whole process during search and seizure if necessary.

At about 16.55 hrs, as per indication of source, I apprehended one small car having Registration No. WB 74 BK 7291 and found five persons including one lady were inside the car, which was coming from Siliguri side. After this, I disclosed our identity and share the information to them which I was received. On being asked, they disclosed their identity as noted above. There is a strong reason to believe that the detained persons were involved carrying contra banned narcotic substances in their car for supplying the same to their designed customers. I then gave them option, whether they wanted to be searched in presence of the Executive Magistrate or by any Gazetted Police Officer. Then they agreed to be searched by Gazetted Police Officer. Further, I served them notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the accused persons to search our Police Party as per provision. But they refused to search the police party. At about 17.15 hrs Shri Prabir Dutta, I/C, Siliguri PS, SPC came to the spot and inform that due to Assembly Election 2026 in West Bengal, no Executive Magistrate was available and hence as per order of Superior Officer, I/C, Siliguri will supervise the process of search and seizure. At about 17.25 hrs, I started the search process in presence of I/C, Siliguri PS, independent witnesses, lady constable found 07 (seven) numbers of mobile phones from their possession as per seizure list. On being thoroughly searched the car, found two plastic transparent packets containing suspected to be Brown Sugar, was hidden over the stepny tyre inside the back side dicky. On demand, they failed to produce any valid document in support of possessing and carrying of the said to be Brown Sugar which was kept inside the dicky of the car.

Accordingly, I weighted the said two packets by the weighing instrument of Central Malkhana, SPC and found One Packet containing 530 grams of suspected to be "Brown Sugar" marked as Exhibit-'A' and other packet containing 520 grams suspected to be "Brown Sugar" marked as Exhibit-'B'. Accordingly, I seized the all articles found from their possession as per seizure list, packed the two recovered plastic packet containing suspected to be Brown Sugar, sealed, labeled which were found from their joint possession at the spot at South Bharat Nagar, near Jorapani Bridge under Siliguri PS. The whole process of search and seizure has been videographed as per provision of law. The seizure was made between 17.25 hrs to 18.15 hrs. On further interrogation the apprehend persons confessed in presence of I/C, Siliguri PS, SPC and other witnesses that they procured the suspected to be Brown Sugar clandestinely from Malda for the purpose of selling the same in high rate to their designed customers at Siliguri area for their personal gain by illegal means. On interrogation they disclosed that they have been dealing in such business of selling the Brown Sugar illegally since few years.

Then, I arrested the above noted accused persons after observing all guidelines of Apex court and issued necessary Memo of Arrest as well as the ground of their arrest. Thus arrested accused persons named (1) Pradeep Kumar Singh@ Sonu(30) S/O- Sri Santosh Singh of Datauli , P.O & P.S-Sahatwar , Dist- Ballia, Uttar Pradesh and (2) Raju Singh (40) S/O- Late Laxman Singh of Madhupur , P.S- Kotwali (City Thana) , Dist-Ballia ,Uttarpradesh have violated the terms and condition of Narcotic Drugs for possessing Ganja without any valid authority & license.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Miss Pujā Rasaily (33), D/o- Ranju Rasaily of Shastri Nagar, near Shib Mangal School, W/No. 41, PS- Bhaktinagar, Dist- Jalpaiguri, (2) Azharuddin Sha (39), S/o- Md. Safique of Gurung Busty, Upper Road near Old Loyola School, W/No. 3, PS- Pradhan

nagar, Dist- Darjeeling, (3) Pappu Giri (48), S/o- Shyam Narayan Giri of Porsupur, PO- Rasepur, PS- Tarwa, Dist- Ajamgarh (U.P.), (4) Md. Samse Alam (35), S/o- Moti Rahaman of Dipnagar, Jamai Bazar, PS- Pradhan nagar, Dist- Darjeeling and (5) Md. Murad Ansari (40), S/o- Abdul Latif of Prakash Nagar, near Kali Mandir, W/No. 43, PS- Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
