I, Meena Bansal, wife of Late Subhash Bansal, resident of Shiv Mandir Road Bylane, Punjabipara, Ward No. 13 of SMC, Siliguri, P.S. Siliguri, District Darjeeling, wish to hereby lodge this written complaint to the following effect:

Smt. Shikha Agarwal is my daughter. The marriage between my daughter and Sri Raman Agarwal (son of Late Sajjan Lal Agarwal) was solemnized on 23rd June 2011 at City Garden, Sevoke Road, Siliguri, P.S. Siliguri, District Darjeeling according to Hindu rites and ceremonies. A daughter (presently aged about 12 years) and a son (presently aged about 8 years) have been born out of the said wedlock. My daughter and her husband along with their children reside at Siddhi Home Apartment, Flat A1, Bhagat Singh Sarani, Punjabipara, Ward No. 13 of SMC, Siliguri, P.S. Siliguri, District Darjeeling. Sri Raman Agarwal is an advocate by profession having chamber/office at Goyal Plaza, Sevoke Road, Opposite Sachitra Hotel, P.S. Bhaktinagar, District Jalpaiguri.

On 22nd of January 2026, Sri Raman Agarwal suddenly revealed to my daughter that he has been having an affair with Miss Rashmi Majumdar (daughter of Sri Jiwan Majumdar, resident of Pradhan Nagar, behind Heritage Hotel, Ward No. 2 of S.M.C., Siliguri, P.S. Pradhan Nagar, District Darjeeling) and that he has become very intimate with Miss Rashmi Majumdar and has decided to marry her. Such disclosure left my daughter and my family members as well as the family members of Sri Raman Agarwal in utter disbelief and mental shock and we all tried to instill good sense in him and pleaded with him to abstain from such clandestine extra marital relationship, but he is adamant in his decision and paid no heed to us. Sri Raman Agarwal has also revealed that Miss Rashmi Majumdar has threatened to commit suicide if he abstains from continuing and carrying forward his relationship with her through marriage. Sri Raman Agarwal has started to behave very violently and rudely with my daughter and the children. I, my daughter and family members still expected that Sri Raman Agarwal will change his decision in the best interest of the children.

Yesterday (07/04/2026), at around 5 PM, Miss Rashmi Majumdar along with her mother and sister met Sri Ravi Agarwal (elder brother of Sri Ravi Agarwal) at

his office at Goyal Plaza, Opposite Hotel Sachitra, Sevoke Road, Siliguri and declared that Sri Raman Agarwal should marry and start living with her immediately or else she will lodge false complaints against Sri Raman Agarwal, my daughter and the family members and commit suicide. In such a situation, Sri Ravi Agarwal called me and my daughter to his office for resolving the matter. Sri Raman Agarwal also arrived there. However, both Sri Raman Agarwal and Miss Rashmi Majumdar showed no interest to discuss and expressed their firm decision to marry. While I and my daughter were coming out of the said office, Sri Raman Agarwal became violent and abused us in filthy language and assaulted us physically in a fit of rage. My daughter has recently undergone gall bladder surgery and the incident and assault left her in a state of trauma.

Today (08/04/2026) at around noon, my daughter attempted to commit suicide at her residence and immediately I and my son (Sri Shekhar Bansal) rushed her to Sunrise Nursing Home, Udham Singh Sarani, Punjabipara, Siliguri where she is still admitted in ICU. Sri Raman Agarwal and Miss Rashmi Majumdar are entirely responsible for the painful condition of my daughter.

Sir, I fervently request you with folded hands to please save my daughter and our family from such torture inflicted upon us by Sri Raman Agarwal and Miss Rashmi Majumdar and take appropriate action against them immediately so that the life of my daughter and her children are not ruined and lost. As I am in immense agony and attending the hospital where my daughter is admitted, there has been some delay in lodging this complaint which may please be condoned.
