I, Sri Dinesh Roy S/O Late Narendra Nath Roy residing at Netaji Pally, Word no. 22 of Siliguri Municipal Corporation, P.O-Rabindra Sarani, P.S-Siliguri, District-Darjeeling do hereby lodged this complain stating that I have filed one Title Suit along with Injunction application before the Ld. Civil Judge, Junior Division Court at Jalpaiguri on 30.03.2026 against Sri Biseshwar Roy @ Subash Roy S/O Late Lakhikanta Roy residing at Netaji Pally, Word no. 22 of Siliguri Municipal Corporation, P.O-Rabindra Sarani, P.S-Siliguri, District-Darjeeling and on 30.03.2026 after hearing Ld. Court passed an order of interim injunction against above noted person as under:- ".....The parties are directed to maintain Status Quo in respect of the title, possession and nature and Character of the Suit Property till next date fixed on 13.07.2026".

Mintu Roy sin of Sri Suresh Roy residing at Farabari Ballam Para, Vorer ALO, Dist.-Jalpaiguri and 3. Kulen Roy son of late Thinthin Roy residing at Farabari, Velki Para ,Voreralo, Sahudangihat, Dist.-Jalpaiguri have continuously carrying disturbing my possession over the suit property illegally. That on today I have tried to resist them from doing such illegal work but they have threatened me.
