In producing herewith the following 05 (five) persons arrested namely 1. Kanai Thakur (24 yrs./M), S/O Lt. Ranjit Thakur of IOC Gate, Ward No. 35, Bhaktinagar, PS- NJP, Dist.- Jalpaiguri, 2. Pradip Roy (19 yrs./M), S/o- Bablu Roy of Haripur, Nichpara, Ambikanagar, Ps- NJP, Dist.- Jalpaiguri, 3. Bappa Barua ( 26 yrs./M), S/o- Khakon Barua of Paschim Dhantala, Chunabhathi, PS- NJP, Dist.- Jalpaiguri, 4. Debashish Sarkar ( 26 yrs./M), S/o- Sibu Sarkar of Chaturagachh, Sipaipara, PS- NJP, Dist. - Jalpaiguri and 5. Sujit Roy ( 24 yrs./M), S/o- Satyen Roy of Ambikanagar, Raod No. 2, PS- NJP, Dist. - Jalpaiguri under arrest along with the following seized articles:-

- VI. One electric torch light
- VII. One Red and blue colour Nylon rope.
- VIII. Total Cash of Rs. 350/- (IC) from the accused Kanai Thakur.

I ASI Nilam Swarnakar of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 9/10 persons to the effect that on the night 12/04/2026 at 00-10 hrs received secret source of information to the effect that some miscreants with deadly weapons assembled in a dark place at Kashmir Colony Ucha Math under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 653 dt. 12/04/2026. As per your kind direction at 00-15 hrs myself along with SI Binup Mahato, ASI Munna Ahamed, C/453 Uttam Dey, C/1462 Sajan Tamang for Kashmir Colony Ucha Math under NJP PS to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 00-25 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the Kashmir Colony Ucha Math under NJP PS , found a group of 09/10 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the above noted five (05) persons and the others 04/05 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in the

adjacent area of Kashmir Colony Ucha Math under NJP PS. Thereafter all the apprehended persons were searched and in presence of independent witness I conducted search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in video graph as per provision of law . Accordingly I arrested the above noted accused persons u/s 35 BNSS after informing the ground of arrest and dully issue of memo of arrest. The whole seizure was made between 01-15 hrs to 01-35 hrs and the all persons were arrested with proper memo of arrest.

Debashish Sarkar ( 26 yrs./M), S/o – Sibbu Sarkar of Chaturagachh, Sipaipara, PS – NJP, Dist. – Jalpaiguri, 5. Sujit Roy ( 24 yrs./M), S/o – Satyen Roy of Ambikanagar, Raod No. 2, PS – NJP, Dist. - Jalpaiguri and other 04/05 persons and arranged for its investigation.
