Respected Sir,

This is to inform you that I Smt. Rupa Das, aged about 22 years <sup>Kawakhari, Medical more Near tank centre</sup> w/o Sanjib Sarkar, resident of <sup>Sushruta Nagar,</sup> Shivmandir, Durgamancher, <sup>Vivekananda</sup> Pally, P.O. <sup>Kadamtala,</sup> P.S. Matigara, Dist-Darjeeling begs to state you that I am married to one Sanjib Sarkar on 03/03/2025 by social marriage. That after marriage I came to know that my husband is having an extra marital affair with a lady. That after knowing such I gradually asked my husband but he denied. That after such incident he started to converse with that other unknown lady through calls and messages. But after confronting him he got furious and started to hit me on various occasions. That on 20/03/2026 when I came back from my work my husband namely Sanjib Sarkar accused me of cheating and started to beat me with fist and punches for which I got several injuries and failing to deal with such distress I consumed poison and tried to end my life. It is pertinent to mention here that previously in the month of July, 2025 the same incident occurred and even then I consumed poison but my husband pressurized me not to take any actions and also threatened me with dire consequences. I would also like to mention that I conceived 2 (two) babies earlier but my husband through different medications aborted my childrens.

That after I consumed poison on 20/03/2026, I felt extremely sick and failing to deal with such agony I finally said the entire incident to my older sister namely Sampa Das, and after that my said sister admitted me to North Bengal Medical College & Hospital and I am undergoing treatment till now (medical documents annexed herewith)

Now finding no other alternatives I am writing you this written complaint and request you to take appropriate/strict legal actions against my husband namely Sanjib Sarkar.
