Respected Sir,

With due regards, I, **SRI ISWAR CHANDRA BARMAN**, Son of Late Ramesh Chandra Barman, Resident of Kalaram Jote, Ghosh Para, P.O. Rangapani, P.S. Phansidewa, Dist. Darjeeling, would like to lodge this written complaint to the effect that that **DIPALI BARMAN** is my elder daughter, whose marriage was solemnized with **SRI BIDHAN BARMAN**, Son of Late Soyalu Barman, Resident of Vill.: Venchijote, House No. 12, Patharghata, P.O. New Champpta, P.S. Matigara, Dist. Darjeeling, Pin: 734009 and their marriage was solemnized on 02/06/2004, according to the Hindu Rites & Customs, after observing all formalities of a Hindu Marriage Ceremony on and from our house situated at Kalaramjote, P.O. Rangapani, P.S. Phansidewa, Dist. Darjeeling and out of their lawful wedlock, two female child were born namely Miss. Reemi Barman (Aged about 21 Years) and Miss. Nobhya Barman (Aged about 12 years).

Sir, since after their marriage, my daughter was subjected tremendous mental and physical torture by her husband, mother-in-law namely Smt. Ajabala Barman, brother-in-laws namely Sri Rabin Barman & Sri Jagadish Barman and sister-in-law namely Smt. Kalpana Barman on regular basis without any just, cause and reason. They always picked up quarrel with my daughter on any tripling issues and also abused her with filthy and slang languages in presence of their children and as and when my daughter made protest against their such type of ill-behavior and torture, they did not bother to assault my daughter physically and inspite of their such type of torture, my daughter used to bear all such type of torture of her husband and in-laws members for the sake of her future conjugal life and also for the future career of her daughters with a hope that they will realize their own mistake and thereby, rectify themselves but all her hopes have gone in vain.

Sir, my son-in-law is a business person and he has been carrying on a business of CCN Cable Distributor and Sinet WIFI Distributor and besides the same, he has also been carrying on a business of Disco Jockey (DJ) Operator and he has been maintaining huge number of clients and doing a profitable business smoothly and inspite of that, he has been neglecting and refusing to discharge his marital obligation to maintain my daughter as well as their daughters.

Sir, since last three years, my daughter noticed that her husband is a person of bad character and he has been maintaining illicit and adulterous extra marital relations with several women and knowing

about his such type of illegal activities, when she made protest against her husband, he became more furious and flatly stated that he is no more interested to lead further conjugal life with my daughter and also threatened her in conspiracy with his family members that if she again raise her voice against her husband, they will not hesitate to oust my daughter from her matrimonial house forcefully and receiving such type of threatening from her husband and in laws members, she kept mum for the sake of their future conjugal life and also for the future career of her minor daughters.

Sir, suddenly on 20/11/2025 at about 09.00 A.M., her husband left the house with his motor cycle bearing Registration No. WB-74AV-2654 on the plea of his work and after some time, when he did not return back to the house, my daughter tried to contact with him over phone (Having Mobile Nos. 98320-38864, 79089-12770, 94741-31409) but all the mobile numbers of her husband were found switched off. Thereafter, we have searched her husband in all possible places to trace out him but could not locate him and finding no other alternative, on 21/11/2025 my daughter had lodged a Missing Dairy before your authority, vide Matigara P.S. GDE No. 1136, Dated: 21/11/2025.

In the meantime, my daughter came to know that her husband fled away with a married lady namely Smt. Puja Roy, Wife of Patit Paban Roy of Ambadhura, Salbari, Near Thukpa Factory, P.S. Pradhan Nagar, Dist. Darjeeling, in a preplanned manner, who is also the distance relative of her in-laws family and to that effect, the husband of said Puja Roy has also lodged a Missing Dairy before the Pradhan Nagar Police Station and thereafter, we also came to learn that the husband of my daughter and said Smt. Puja Roy got married with each other and started to live together as husband and wife, inspite of the fact that their marriage is still subsisting and presently, her husband in connivance with said Smt. Puja Roy have been creating pressure upon my daughter to give her consent in mutual divorce and when she refused the same, he started to threaten us with dire consequences.

After few days, my son-in-law again return back to his house and immediately after his arrival, he in conspiracy with his family members have started tremendous mental and physical torture upon my daughter on regular basis and they confined her forcefully in a room, so that she could not able to contact with us or anybody. They have also snatched her mobile phone and damaged the SIM card and on being protest, her husband and other in laws members mercilessly beaten her with an intention to kill her. It is to be mentioned here that my son-in-law and his family members in conspiracy with the said lady namely Smt. Puja Roy forced my daughter to commit suicide and in order to fulfill their ill motive, they have obtained a written declaration from my daughter stating inter-alia that "if she commit suicide, her husband and her mother-in-law will not be responsible in any way" and my

granddaughters namely Miss. Reemi Barman and Miss. Nobbya Barman have stated the said facts to us and also told us that if we fail to recover my daughter from the said house immediately, they will definitely murder my daughter and after receiving the said information from my granddaughters, we have not received any sort of further information about my daughter. Not only that, my younger granddaughter namely Miss. Nobbya Barman had sent a CCTV Footage, wherefrom it will be cleared that how and in what manner they are assaulting my daughter.

Sir, on 06/04/2026, my wife and her brother and other family members have visited the matrimonial house of my daughter namely Dipali Barman with an intention to meet with my daughter and also to gather the information about my daughter but the in laws members of my daughter have misbehaved with them and even did not allow my daughter to talk with them and finally, they leave the place. It is our strong believe that my son-in-law namely Sri Bidhan Barman and his family members in conspiracy with the said lady namely Smt. Puja Roy might be killed my daughter or due to their constant physical torture, abetment and provocation, my daughter might be commit suicide at any point of time if she is not recovered from her matrimonial house immediately and we are worried about her life as well as the life her two daughters.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against my son-in-law and his family members as mentioned above and said Puja Roy as per the provision of law and obliged thereby.

Your early action is highly solicited.
