Respected Sir,

I. SRI SOURAV SARKAR, Son of Sri Sudip Sarkar, resident of Saradapally, Ward No. 37 of S.M.C., P.S. Bhaktinagar, Dist. Jalpaiguri, in the State of West Bengal and the existing President of Bharatiya Janata Yuba Morcha, Siliguri District Organization, would like to draw your kind attention to the very effect that yesterday i.e. on 07-04-2026 at around 10.50 PM, I along with few party Karyakartas of my organization for the sake of organizational work were moving from Air View More to Jalpai More Siliguri area with our rented vehicle, at the relevant point of time when We were passing through the Jhankar More, Siliguri, one Bullet bike No. **WB74BC5784** without following my vehicle movement, under complete confusion under own rash and negligent manner felt on road without being hit by our said vehicle. On seeing so, We stopped and went out from our vehicle to verify his condition. We found him under drunken condition and on our query, he informed his name as **NIRAJ KUMAR SAH**, a resident of Ward No. 5 of S.M.C. and thereafter without spending any sort of time, I instructed my other Karyakartas namely 1) Mithilesh Sah and others to take him to the Hospital under immediate effect. Accordingly, my fellow Karyakartas brought him to Siliguri District Hospital and he had been medically treated at emergency section in presence of our fellow Karyakartas and on due satisfaction by the attending Doctors, he had not been admitted but under due prescribed requisition by the attending Doctor left from the Hospital. He was taken to his house and my fellow organizational Karyakartas, gave their contact numbers for any further needs and thereafter my Karyakartas left him. It took me under utter disgrace that from today's morning, the said Niraj Kumar Sah through his men frequently called my fellow karyakartas and even me from various numbers and were demanding money with a blackmailing manner to lodge complaint against me with an aid to defame my political repute during the course of prior Assembly election movement. When I along with my fellow karyakartas denied his demand, he threatened and continued to blackmail me and my fellow karyakartas. It is right place to mention here that the whole incident held at Jhankar More, Siliguri region and the said region is completely under CCTV surveillance and I do hereby urged the police administration to verify the very incident with effect that whether any mistake held from the end of our vehicle or not and moreover, it is trite to be mentioned here that the very Niraj Kumar Sah was in drunken condition and he was driving in gross reckless and negligent manner for which he shall have to be prosecuted under due process of law including his crime to illegal demand by way of blackmailing me and my fellow karyakartas. The issue is more alarming to be cross checked, whether any instigating/ill conspiring head of ruling Trinamul Congress party is existing therein or not, for maligning me and my political party repute prior to the upcoming Assembly election, 2026. I am expecting and/or demanding free and fair enquiry in this entire incident from the administration.

I am, therefore, requesting you to take appropriate legal action/s against the above-named Niraj Kumar Sah and his associates in blackmailing me and fellow karyakartas for the proper administration of justice.
