Officer Sir,

I, Pratik Goyal, S/O Sri. Shankar Agarwal aged 38-years, resident of Ananda Bari, P.O.- & P.S.- Siliguri, District- Darjeeling, West Bengal hereby being compelled to file this written complaint against 1. **Dilip Kumar Agarwal** S/O Lt. Sita Ram Agarwal, 2. **Ayush Agarwal** S/O Sri. Dilip Kumar Agarwal 3. Smt. **Sunita Agarwal** W/O Sri. Dilip Kumar Agarwal all three persons are residents of Flat No.- 203, Club Town Complex, 2 1/2 Mile, Sevoke Road, Siliguri for physical assault causing grievous hurt attempting to murder, conspiracy, snatching, cheating, fraud, criminal conspiracy amounting to financial fraud, criminal breach of trust tantamount to severe untreatable physical heart condition, mental torture, irreparable financial loss that has led to our present psychological state of mind and health that pertains to take drastic steps of family committing suicide.

1. That I, being one of the partner of our firm Shri Maharaja, a food catering service provider was on dated 06/09/2025, approached by the above named three persons to provide food catering services for three days and nights program for their invited guests for the wedding celebration of Sri. **Ayush Agarwal** S/O Sri. Dilip Kumar Agarwal (Bridegroom) & Smt. **Sweetie Agarwal (Kandoi)** D/O Sri. Pradeep Kumar Agarwal (Kandoi) venue being Hotel Mechi Crown Plaza, Dhulabari, District- Jhapa, Country- Nepal on dated 05/02/2026 for a contract of Rs. 24,20,000/- plus additional applicable GST (Goods & Tax Services) for which an amount of Rs. 1,01,000/- (One lakh One Thousand) only was given to us as advance at our restaurant at station Feeder Road on dated 06/09/2025 and the balance amount of Rs. 23,19,000/- (Twenty Three Lakhs Nineteen Thousand) only was to be paid within 07 days after completion of their marriage program.

2. That upon approaching for the balance payment on the due date I was requested by the above named three persons to wait for another two weeks as they had temporary financial constraints due to their marriage higher and over spendings. This episode of delay providing false excuses went on until dated 10/04/2026, time 5:00pm.
3. That I along with my father Sri. Shankar Agarwal S/O Lt. Gulab Chand Agarwal went to buy flowers for House Puja at Station Feeder Road, Near Hindi High School on 10/04/2026 at about 05:00pm where we found Sri. Dilip Kumar Agarwal & Ayush Agarwal standing near Hindi High School for the purpose better known to them.
4. That at first Sri. Dilip Kumar Agarwal & Ayush Agarwal approached us and started high pitch verbal altercations with my father absolutely denying to pay our balance outstanding payment of Rs.23,19,000/- (Twenty Three Lakhs Nineteen Thousand) only at the first outset and out of blue threatening us to never show our faces to them in future for the said outstanding payments.
5. That my father at that moment requested them not to deny our balance outstanding money that is an outcome of the hardest work of my entire family members, materials and best services but the shocking most instant moment was Sri. Dilip Kumar Agarwal & Ayush Agarwal out of the blue hit and held my father by his collar, snatched his gold chain and started hitting him right and left with blows on his chest injuring the part of his chest where my father has been a patient of coronary heart surgery with an insertion of expandable mesh tube (stent) on his heart. He immediately fell very seriously ill and asked me to take him home to my mother and his mother.
6. That he had undergone medical examination in Siliguri Sadar Hospital, emergency ward (medical examination report enclosed).

That I demand an immediate lawful stringent action against 1. **Dilip Kumar Agarwal** S/O Lt. Sita Ram Agarwal, 2. **Ayush Agarwal** S/O Sri. Dilip Kumar Agarwal 3. Smt. **Sunita Agarwal** W/O Sri. Dilip Kumar Agarwal all three persons for the above matter for committing crimes of battery, physical assault causing grievous hurt attempting to murder, conspiracy of financial fraud, snatching, cheating, fraud, criminal breach of trust tantamount to severe untreatable physical heart condition, mental torture, irreparable financial loss that has led to our present psychological state of mind and health pertaining to take drastic steps of family committing suicide. That immediate course of lawful action is demanded to meet the ends of justice.
