

On the basis of information received regarding possible cattle smuggling from kristopur a Special Naka Party of coy hrq madanjote under the command of UIN-13150171 SI(GD) bhagwat singh , along with 05 other personnel on the night of 25/03/2026 moved towards kristopur village from govt veh no WB 74 BP 9563. while approaching towards kristopur a TATA truck bearing no WB 73 E-0279 coming towards halal village was seen after seeing our govt vehical they stopped the truck and flee away in rush and chase we caught a person who is a labour in this truck a thorough search was conducted then 24 nos of male buffalow were recovered in this truck he failed to produce any document related to transportation of these cattle .during interrogation apprehended person reveled his name Md.Mujahed s/o Md. Safikil,Kaluajote , kamala PO.Naxalbari Dist-Darjeeling (W.B.) Aadhar NO.5740 7977 4661 mob no. 7902290913.

He also revealed that MD. ANASUL of totaram jote village Naxalbari (A Notorious Cattle smuggler) purchase these male buffalo from Nepal illegally arrange crossing International Border via Naxalbari then MD. ARMAN of Totaram jote & MD. ISTAG ASHRAFI S/O Md. Saleem of Totaram jote who runs a khoar (pashu bada) and MD. ALIMUDDIN of Kaluajote Boropole arrange transporting these cattle illegally to Assam.in a very organized manner with help of these syndicate.


The manner in which the cattle were loaded for transportation clearly indicated intention to illegally transport the smuggled buffaloes and cruelty towards those buffaloes A seizure memo was duly prepared in the presence of force witnesses at 0200 hrs as per prescribed procedure.

In view of the above the seized buffaloes 24 NOS. & tata truck registration no WB 73 E-0279 along with apprehended person are being handed over to Bagdogra Police Station on 25/03/2026 at 06:45 hrs. .... hrs. for further lodging a Fir against these cattle smuggling syndicate and legal action.
