Subject: Complaint regarding brutal physical assault, criminal intimidation and outraging modesty by 1. Nima Tamang Son of Amit Tamang, 2. Pema @ Chunnu Tamang Son of Amit Tamang, 3. Yanki Tamang Daughter of Amit Tamang, 4. Pankaj Son of unknown), 5. Amit Tamang and others.

Respected Sir,

I, Apeksha Lama Sherpa, wife of Sunny Tamang, resident of Netaji Nagar, near Health Centre, Salugara, District Jalpaiguri, hereby lodge this complaint regarding a serious incident of brutal physical assault upon me and my husband.

That today i.e. 09.04.2026 at around 6:30 PM, I received a phone call from my mother-in-law informing me that my husband was being physically assaulted by certain individuals near Bengal School, behind Vega Circle Mall, Sevoke Road. Upon receiving such information, I immediately rushed to the spot, where I found my husband being brutally assaulted by Nima Tamang (son of Amit Tamang), Pema @ Chunnu Tamang (son of Amit Tamang), Yanki Tamang (daughter of Amit Tamang), and one Pankaj (son of unknown), all residents of Salugara, Santipara, Ward No. 42, District Jalpaiguri. Thereafter, Amit Tamang along with another person also joined and further assaulted my husband.

When reached their and when I tried to intervene and stop the assault, the accused persons also turned upon me and brutally assaulted me. In the course of the said incident, Amit Tamang and Pema @ Chunnu Tamang caught hold of my hair, dragged me on the road, and physically manhandled me in a violent manner. They also touched me in an inappropriate manner

with the intention to outrage my modesty, causing me severe physical pain, humiliation, and mental trauma. The accused persons further attempted to strangulate me and used criminal force against me without any provocation.

Due to the severe assault, my husband sustained serious injuries and was immediately taken for medical treatment at Siliguri District Hospital, where a police case medical slip was issued. As per the medical record, my husband Sunny Tamang @ Sonny Tamang (Male, approximately 26 years) was examined on 09.04.2026, and the history of physical assault has been duly recorded therein.

The acts of the accused persons were deliberate, unlawful, and carried out with clear intention to cause grievous harm. They also threatened that they would kill me and my husband if they find us again, thereby creating fear and panic in our minds as well as in the locality. Their actions amount to serious cognizable offences under law, including physical assault, criminal intimidation, use of criminal force against a woman, and outraging modesty.

In view of the above facts and circumstances, I most respectfully request you to kindly register an FIR against the above-named accused persons under appropriate provisions of law, take immediate and strict legal action against them, and ensure protection for me, my husband, and my family members. I am ready and willing to cooperate fully with the investigation and shall provide all necessary documents, including medical reports, as and when required.

Kindly treat this matter as urgent and take necessary action at the earliest.
