Subject - FIR/Complaint

Respected Sir,

With due respect I, Arun Singh, Son of Kamal Singh, resident of Kamala Nagar, Ward No. 42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal - 734008 begs to state that (1) Sunny Tamang, and (2) Nishan Tamang, both are Sons of Raj Tamang and resident of Prakash Nagar, near Ektiasal B.S.P. School, P.O. Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal on 09.04.2026 at about 06:30 pm suddenly apprehended my son Pankaj Singh and started assaulting him with sharp weapons. The aforesaid persons attacked my sons with sharp knives on his neck/throat with the intention to kill him and he sustained deep bleeding injuries and cuts on his neck with the said knives. My son Pankaj Singh lost his consciousness on the said spot and when they thought that my son died due to the bleeding they left the said spot. Somehow the family members of my son were informed about my son's condition and we rushed to save the life of my son. Then we took my son Pankaj Singh to the Siliguri Sadar Hospital and seeing my son's condition he was admitted to the Hospital. As we are poor person and unable to bear the travelling cost and other expenses, I requested the Doctor to discharge my son and accordingly he was discharged under our request. The condition of my son is still very serious and is present under medical supervision at our home. I could not lodge any complaint before the police authorities as I was engaged in the treatment of my son.

So I therefore request before you to kindly look into the matter and do the needful to start a specific case against the aforesaid person under the provisions of law.

I shall be highly obliged for this act of kindness.
