In producing herewith following three accused persons named (i) Shubhajit Das, aged 23 years, s/o- Late Shankar Das, resident of Kawakhali Township, PS- Matigara, Dist- Darjeeling, (ii) Abhijit Das, aged 20 years, s/o- Late Shankar Das, resident of Kawakhali Township, PS- Matigara, Dist- Darjeeling and (iii) Prince Minj, aged 23 years, s/o- Ramlal Minj, resident of Hansquan, Dulur Chhat, PS- Bagdogra, Dist- Darjeeling (all not verified) under custody along with following seized articles:

- (i) One torch light styled as 'Eveready DG LED' and marked as Exhibit- A.
- (ii) One knife with wooden handle and marked as Exhibit- B.
- (iii) One 'Kalam chhuri' measuring approx length 10 (ten) inches & wooden handle length 6 inches and marked as Exhibit- C.
- (iv) One blue colour backpack styled as "Skaybags" and marked as Exhibit- D.
- (v) One nylon rope measuring approx length 15 feet and marked as Exhibit- E.
- (vi) One iron rod measuring approx length 26 inches and marked as Exhibit- F.

I, SI Debabrata Kundu of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested three involved accused persons and other 4/5 absconding unknown miscreants to the effect that today on 29.03.2026 at 00:15 hrs I received reliable source information that a group of 8/9 suspects have assembled beside NH-27 near Khanna hotel under Bagdogra PS with a preparation to commit dacoity at Bagdogra area. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I formed a raiding team consisting ASI Amit Lama, VP/01 Anselam Kujur & CV/386 Kishor Ranjan Howladar leaded by me. Then we left for NH-27 near Khanna hotel under Bagdogra PS by Govt. vehicle No. WB61A/0137 to work out the secret source information. This refers to Bagdogra PS GDE No. 1338 dated 29.03.2026. On the way I contacted with night K-36 mobile van officer ASI Ranjit Barman to accompany with us at the above noted PO. Then ASI Ranjit Barman along with force HG/1118 Dipesh Singha & CV/923 Pandit Nagesia accompanied with us. At around 00:45 hrs we reached near Khanna hotel beside NH-27 and made an ambush there and waited for source indication. We parked our Govt. vehicles away from the place. After a while, source indicated us the place where the group of suspects assembled. There were a group of about 8/9 suspects near Khanna hotel beside NH-27. Then, being shown & indication by source we started to cordon them from all side. All of a sudden, some of them noticed us and tried to flee away from the spot. But after hot chase with the help of accompanying Police team I managed to apprehend three suspects there in red-handed at around 01:35 hrs. We searched for independent witnesses. One independent witness named Shibu Singh, aged 32 years, s/o- Late Tapan Singh, resident of Tumbajote near Jora Bridge, PS- Matigara, Dist- Darjeeling (Ph. No. 7001815745) was present there. Accordingly, I arranged to search their persons in presence of the independent witness as well as the Police witnesses. On search, one torch light, one knife, one 'Kalam chhuri', one backpack, one nylon rope, one iron rod were recovered from their joint possession. Accordingly, I interrogated them.
