Sir,

In producing herewith the accused person named Shutku Lohar, aged 36 years, s/o-
Shambhu Lohar, resident of Putimari, PS- Bagdogra, Dist- Darjeeling (Aadhaar No. 3604 6788
7372) under custody along with following seized articles under proper seizure list:

1. One multicolour nylon bag and marked as Exhibit-A.
 2. Twenty-four (24) bottles COSMOS Classic Red 70° UP Indian Made Liquor, each contains
300 ml @ Rs. 50/-; out of which 01 bottle is taken out as sample and marked as Exhibit-B.
- (Total 7.2 ltrs liquor, total value Rs. 1200/-)

I, SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this
written complaint against the arrested accused person named Shutku Lohar, aged 36 years, s/o-
Shambhu Lohar, resident of Putimari, PS- Bagdogra, Dist- Darjeeling to the effect that on
29.03.2026 at around 21:05 hrs I received reliable source information that one suspect will come at
Singhijhora more beside AH-02 under Bagdogra PS with huge quantity of liquor in his possession
with a view to sell the same illegally to his designed customer for his wrongful gain. Accordingly, I
informed the matter to O/C Bagdogra PS and as per his direction I along with ASI Amit Lama,
VP/02 Pradip Roy, CV/389 Janak Singh & CV/375 Jogesh Barman left for Singhijhora more beside
AH-02 under Bagdogra PS, SPC by Govt. vehicle No. WB61A/0137 to work out the secret source
information. This refers to Bagdogra PS GDE No. 1377 dated 29.03.2026. Under these
circumstances any search warrant or authorization cannot be obtained without affording
opportunity for the concealment of evidences as well as of the escape of the offender. At around
21:15 hrs we reached near Singhijhora more beside AH-02 and ambushed there keeping the vehicle
away and had been waiting for source indication. After a while being indication & identification by
source at around 21:45 hrs I managed to apprehend one suspect with the help of accompanying
Police personnel and interrogated him. On interrogation, he revealed his identity as Shutku Lohar,
aged 36 years, s/o- Shambhu Lohar, resident of Putimari, PS- Bagdogra, Dist- Darjeeling. We
disclosed our identity to him and the input we had. We searched for the independent witnesses to be
present there as witness during the process of search, seizure, if any. One independent witness
named Mukesh Ray, aged 27 years, s/o- Biren Roy, resident of Nunujote, Singhijhora T.E, PS-
Bagdogra, Dist- Darjeeling (Ph. No. 7586838764) was there to witness the process of search and
seizure, if any. Then, we searched the suspect who had carried a loaded nylon bag on his
possession. On searching the bag, twenty-four (24) bottles of COSMOS Classic Red 70° UP Indian
Made Liquor, each contains 300 ml @ Rs. 50/- was recovered from the said bag. On demand, the
detainee failed to produce any valid document/license for possessing & carrying that liquor. He
confessed that he has been possessing, carrying & selling liquor illegally since long time for his
wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as
noted above) including the nylon bag from his possession under proper seizure list in presence of
independent witness and other Police personnel. At last, I arrested the involved accused Shutku
Lohar (as noted above) after observing all legal formalities and communicating him the ground of
arrest in writing as he has committed a cognizable offence in presence of Police Officers for
possessing & carrying that liquor illegally and issued memo of arrest in this regard. The process of
search, seizure & arrest is made in between 21:45 hrs and 22:05 hrs on 29.03.2026 through audio-
video electronic means using Govt. mobile App 'WB E-Shakshya' vides Evidence Certificate No.
C-1377-63416-20260329223219.
