Sir,

In producing herewith the accused person named Kalu Barman, aged 51 yrs, s/o- Late Haladhar Barman, resident of Biman Nagar, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

- (i) Five (05) bottles of Tuborg Strong Premium Beer, each contains 650 ml @ Rs. 160/-; out of which 01 bottle is taken out as sample and marked as Exhibit-A.
 - (ii) Four (04) bottles of Kingfisher Imperial Strong Beer, each contains 650 ml @ Rs. 160/-; out of which 01 bottle is taken out as sample and marked as Exhibit-B.
 - (iii) Two (02) bottles of Iconiq White Grain Whiskey, each contains 180 ml @ Rs. 200/-; out of which 01 bottle is taken out as sample and marked as Exhibit-C.
 - (iv) Four (04) bottles of Old Monk XXX Premium Rum, each contains 180 ml @ Rs. 170/-; out of which 01 bottle is taken out as sample and marked as Exhibit-D.
- (Total 6.930 ltrs liquor, total value Rs. 2520/-)

I, SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person named Kalu Barman, aged 51 yrs, s/o- Late Haladhar Barman, resident of Biman Nagar, PS- Bagdogra, Dist- Darjeeling (not verified) to the effect that on 03.04.2026 at around 18:25 hrs in course of performing PC mobile van duty vide Bagdogra PS GDE No. 142 dated 03.04.2026, I received reliable source information that a huge quantity of liquor is stored at the house cum shop of one Kalu Barman situated at Biman Nagar under PS- Bagdogra and the same has been selling illegally. Accordingly, I along with ASI Amit Lama, VP/02 Prodip Roy & CV/389 Janak Singh left for Biman Nagar to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as of the escape of the offender. At around 18:55 hrs we reached at Biman Nagar. The source indicated the house cum shop. We saw some customers in front of the shop. Seeing the Police personnel, they fled away from the spot. Then we held raid at the house cum shop of the suspect Kalu Barman and managed to apprehend one person at the spot and interrogated him. On interrogation, he revealed his identity as Kalu Barman, aged 51 yrs, s/o- Late Haladhar Barman, resident of Biman Nagar, PS- Bagdogra, Dist- Darjeeling and introduced himself as the owner of said house cum shop. We disclosed our identity and the input we had to him. We contacted with the local people to be present as witness during the process of search, seizure, if any but none found available to witness the process of search & seizure, if any. Then, we conducted search at the house cum shop in presence of Police personnel. On search, the above noted liquor was recovered from the said shop. On demand, he failed to produce any valid document/license for possessing, stocking and selling that liquor. He further confessed that he has been stocking and selling liquor illegally from the said house cum shop for a long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) from his possession under proper seizure list in presence of Police personnel. At last, I arrested the involved accused Kalu Barman (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police Officers for possessing, stocking & selling liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest is made in between 18:58 hrs and 19:24 hrs on 03.04.2026 through audio-video electronic means using Govt. mobile App 'WB E-Shakshya' vide Evidence Certificate No. C-142-64987-20260403224000.
