**Sub: Complaint regarding cheating and theft of Gold Bangle.**

Respected Sir/Madam,

I, **SRI RAJ KUMAR MITTAL**, Son of Chandu Lal Mittal, resident of Radha Swami Niwas, 85/1, Shiv Mandir Road, Punjabi Para, Siliguri, P.O. & P.S. Siliguri, District - Darjeeling would like to state the following:

1. Today, i.e, 12.04.2026, between 10:50 am to 11:10 am, while I was travelling in a toto (e-rickshaw) from Aalishan Restaurant & Bar to Sidhi Signature Apartment to visit my Elder Brother's residence. Two unknown persons riding a Red colored motorcycle randomly came near my toto (e-rickshaw) stopped me on the way and then approached me and showed some form of identification with picture of them in police uniform, claiming themselves to be police officers in civil dress.
2. They questioned me about wearing a Gold (sona) Bangle on my hand and instructed me to remove it immediately, stating that it was not safe to wear such jewellery openly. They further told me to wrap it and keep it safely. In this manner, they convinced and manipulated me into removing my Gold (sona) Bangle and hand it over to them, believing them to be police personnel.
3. After I handed over the Gold (sona) Bangle to them, they wrapped it in paper and returned it to me. However, they left immediately, upon opening the packet, I discovered that they had replaced my original Gold (sona) Bangle with some duplicate Ladies Bangle and had fled with my original Gold (sona) Bangle.
4. I have been cheated and my Gold (sona) Bangle has been stolen by these unknown persons who falsely impersonated themselves to be police officers.
5. I request you to kindly register a Written Complaint in this matter and take necessary legal action against the Accused Persons at the earliest. I also request you to help recover my stolen Gold (sona) Bangle that had Radha Swami written and measured approx. 30 grams.
