**Sub: Letter of Complaint against Amoda Pradhan S/o Lt Ramprasad Pradhan of Bikashnagar, salugara , PS - Bhaktinagar Dist - Jalpaiguri for illegal storing of Domestic Gas Cylinder and Commercial gas cylinder at his house .**

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

- 1) Total 05(Five) numbers of Bharat petroleum Domestic Gas Cylinder fully empty.
- 2) Total 03 (Three) numbers of Bharat petroleum Commercial gas Cylinder fully empty.

I ASI Chandi Roy of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Amoda Pradhan (42 Years) S/O Lt Ramprasad Pradhan of Bikashnagar, salugara , PS - Bhaktinagar Dist - Jalpaiguri to the effect that on 13/04/2026 at about 14:45 hrs received a secret source information that one Amoda Pradhan (42 Years) S/O Lt Ramprasad Pradhan of Bikashnagar, salugara , PS - Bhaktinagar Dist - Jalpaiguri is illegally storing and selling Domestic LPG and Commercial cylinders i.e. Bharat petroleum Domestic Gas Cylinder at his house for the purpose of selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No. 69 /26 Dt. 13.04.2026 and informed the matter to ACP EB, SPC and as per his instruction myself along with ASI Pranab Kumar Majumdar, ASI Arghya Das, L/C 1270 Deeptina Gazmer and C/1832 Nabab Sk all of EB, SPC left EB Office to proceed Bikashnagar, salugara, PS - Bhaktinagar Dist - Jalpaiguri to execute the information. This refers EB, SPC GDE No.70 Dt. 13.04.2026.

At about 15:55 hrs we reached at Bikashnagar, salugara, PS - Bhaktinagar Dist - Jalpaiguri and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the house of Amoda Pradhan (42 Years) S/O Lt Ramprasad Pradhan of Bikashnagar, salugara , PS - Bhaktinagar Dist - Jalpaiguri and found that the above noted accused person is storing and selling loaded LPG and Commercial cylinders i.e. Bharat petroleum . On searching, the above noted seized articles have been recovered from his house. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Amoda Pradhan (42 Years) S/O- Lt Ramprasad Pradhan of Bikashnagar, salugara , PS - Bhaktinagar Dist - Jalpaiguri is storing and selling the Domestic and Commercial gas cylinders at his house for his wrongful gain. As per local enquiry it came to light that the above noted person storing and selling gas negligently with respect to fire or combustibile matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Amoda Pradhan does not have any valid License/ Permit of dealing /distribution / selling and storing LPG. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of witnesses namely 1) Raja Ram Shaw ( 43 Years ) S/O Lt Bindeshari Shaw, Bikashnagar, PS - Bhaktinagar Dist - Jalpaiguri . 2. Koushik Mandal (34 Years) S/O Ram Ch. Mandal of Matigara Govt Colony, PS - Matigara, Dist - Darjeeling. The seizure was made in between 16:10 hrs to 16:35 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Md. Amoda (42 Years) Pradhan S/O Lt Ramprasad Pradhan of Bikashnagar, salugara , PS - Bhaktinagar Dist - Jalpaiguri U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
