Subject: FIR

Respected Sir/Madam,

I, **Arati Dayal**, D/o Ram Dayal Choudhary, aged 30 years, residing at Kiran Sadan, House No. 226, Ward No. 5, Santoshi nagar, River Side, Siliguri, District – Jalpaiguri, West Bengal – 734005, do hereby state on oath as under:

On 12.04.2026 at around 4:30 PM, I was at home along with my mother Kiran Choudhary (52 years) and my sister Ravina Choudhary. At that time, the following three persons who reside exactly opposite our house in Santoshi nagar – namely Kamesh Mahato, Madhu Mahato and Pappu Mahato – were washing their water tank and deliberately disposed dirty, foul-smelling water on the road right in front of our house. This caused great difficulty in ingress and egress to our house. When I and my mother objected to this act, the accused persons immediately started giving filthy slangs and abuses to me and my mother. On hearing the quarrel, other family members of both sides came out. At this stage, Pappu Mahato suddenly undressed himself in public view and, armed with drain pipe, started brutally hitting me, my mother and my sister. He also tried to outrage our modesty by tearing our dresses. The other two accused Kamesh Mahato and Madhu Mahato actively participated, instigated and supported the assault.

As a result of the assault we sustained the following injuries: Myself (Arati Dayal) received a laceration on right middle finger and multiple circular bruises on left forearm; my mother Kiran Choudhary received graze abrasion on left elbow and injury on lower back; my sister Rabina Choudhary received linear abrasion marks on left palm, injuries on head, back and chest. All three of us were immediately rushed to Siliguri District Hospital where we were treated as Medico-Legal (Police) Cases. The hospital slips clearly mention “Trauma by physical assault”

It is relevant to mention here that the same accused persons had previously attacked our family and a criminal case was already registered by my father Ram Dayal Choudhary against them at Siliguri Police Station vide FIR No. 532/23. Even after that case, the accused persons have been repeatedly threatening to kill us and our entire family every time my father is out of the house and my brother is out of station. On 12.04.2026 also they threatened to kill us while we were alone at home.

The entire incident was unprovoked and was committed with common intention by the three accused persons who live just opposite our house. **I am in constant fear and threat to my life** and the lives of my family members. We are now living in constant fear of further attack and threat to our lives and modesty.

So, requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
