Subject: Complaint regarding unauthorized operation of drone in violation of promulgated prohibitory orders during the public meeting of the Hon'ble Prime Minister at Kawakhali Ground, Siliguri

Sir,

I, SI Bijay Sarkar, presently posted at New Jalpaiguri Police Station under Siliguri Police Commissionerate, do hereby respectfully submit that on 12.04.2026, I was duly detailed for law and order duty in connection with the visit and public meeting of the Hon'ble Prime Minister at Kawakhali Ground, Siliguri, vide SPL CC No. 74 dated 12/04/2026.

This is to noted here that today on 12/04/2026 at around 17.05 Hrs AC-II Pushpinder Singh National Security Guard (NSG) produced the one operator/owner of the drone, namely Amar Kumar Shah, along with one DJI Mini 2 drone and its remote control before NJP PS. Accordingly the duty officer namely SI Biplab Sen through telephone informed the matter to Inspector-in-Charge, New Jalpaiguri Police Station and as per the direction Inspector-in-Charge, New Jalpaiguri Police Station, the duty officer informed the matter to me for necessary action. This refers to NJP PS GDE No-683 Dated 12/04/2026.

During the course of preliminary enquiry it could be revealed that the Anti-Drone (AD) team of the National Security Guard (NSG), led by AC-II Pushpinder Singh, along with team members CT Sajin M, R-II Srikant Rehara, and CT Abhisekh Roy, was strategically deployed at the rooftop of AD-1 EWS Building and AD-2 HIG under-construction building for surveillance and security purpose. That, at about 11.45 Hrs, the said AD team detected and observed one drone, identified as DJI Mini 2, flying at an approximate distance of 200 meters from the main venue of public meeting of the Hon'ble Prime Minister at Kawakhali Ground, Siliguri that is the restricted and secured zone of the venue.

That, acting upon such detection and in compliance with established anti-drone security protocol; the said drone was neutralized by jamming under the direction and order of AC-II Pushpinder Singh. The matter was immediately reported to Maj. Neeraj Pandey, Duty Officer, NSG HQ, and to the designated nodal officer of the local police, namely ACP Ahitangi Chakraborty.

That, acting under the direction of the I/C NJP PS, I diarized the matter and seized the following;

- i) One (01) DJI Mini Drone (Grey Colour) containing 08 (Eight) plates of fan, styled as 01 unfold the front arms forward, 2 unfold the rear arms downwards Marked as **Exhibit A** which containing one SD memory card styled as HP, 32 GB (blue and white colour) marked as **Exhibit B**
- ii) 03(Three) Nos of Li-ion battery grey colour each one of maximum charge voltage 8.8 v & normal voltage 7.7 dc marked as **Exhibit C,D,E**
- iii) One (01) black colour drone carry bag styled as DJI 'Fly Beyond' marked as **Exhibit F**

Remanded on 12/04/2026 at 18:10 Hrs vide NJP PS GDE NO - 690 dated 12/04/26 and started NJP PS case NO- 222/26 dt 12/04/26 u/s 273(a) BNS and handed to SI Keyi Rajaul Kowin for its investigation

- iii) One (010 black colour drone carry bag styled as DJI "Fly Beyond" marked as **Exhibit F**
- iv) One remote control styled as DJI grey colour, Auctal 04566-2007248 marked as **Exhibit G**, from the possession of the aforesaid individual under a proper seizure memo, in the presence of witnesses and under proper videography, maintaining due compliance with legal formalities. The seized articles were handed over to PS Malkhana officer.

That, upon interrogation, the said individual disclosed his identity as Amar Kumar Shah (38/M) SO- Ajay Kr Shah of Relly Road, PO/PS- Kalimpong, Dist- Kalimpong However, he failed to produce any valid authorization, license, or permission for operating the said drone within the notified restricted zone.

That, it is pertinent to state that the said act constitutes a clear and willful violation of the prohibitory orders duly promulgated by the Learned Commissioner of Police, Siliguri Police Commissionerate, and the Special Executive Magistrate Shri Syed Waquar Raza, IPS, in exercise of powers conferred under Section 163 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), as empowered by the State Government vide Notification No. 1548/1(8)-P.S. Cell/HR/O/3P-42/14 dated 16.08.2022.

That, as per the said order, flying of drones, hot air balloons, and other aerial objects capable of interfering with airspace security was strictly prohibited within a radius of 5 (five) kilometers from the periphery of Kawakhali Ground under NJP Police Station limits for the period from 11.04.2026 at 06:00 hours to 12.04.2026 at 18:00 hours, vide Memo No. 1831(120)/DS dated 06.04.2026 issued by the Director of Security, Government of West Bengal, in connection with anti-drone measures during VVIP/VIP movement. That, in view of the above facts and circumstances, the act of the accused amounts to violation of duly promulgated lawful orders and poses a potential threat to public safety and VVIP security.

That, accordingly, the accused person namely Amar Kumar Shah (38/M) SO- Ajay Kr Shah of Relly Road, PO/PS- Kalimpong, Dist- Kalimpong was lawfully arrested under proper memo of arrest, observing all legal formalities and ground of arrest is duly communicated with him.

Therefore, it is most humbly prayed that a specific case may kindly be registered against the accused person, namely Amar Kumar Shah (38/M) SO- Ajay Kr Shah of Relly Road, PO/PS- Kalimpong, Dist- Kalimpong, under appropriate provisions of law and arrange for its investigation.
