
With due respect, I Khadem Ali S/O Ajahar Ali residence of Vill- Kawatika, PS- Bijni, Dist. - Chirang, Assam would like to inform you that on 05.04.26 at around 16.00 hrs my younger brother namely Afjal Hussain (age 34 yrs) S/O Ajahar Ali of Vill- Kawatika, PS- Bijni, Dist. - Chirang, Assam left for Siliguri for his own business. On 06.04.26 morning he reached at Siliguri and inform us. On the same i.e on 06.04.26 evening at around 3/4 PM we received phone call from my said brother Afjal Hussain having Mobile No 8119983189 that he has been kidnapped by 10/12 persons and demanded Rs 20 lakhs for releasing him otherwise he will be face dire consequences. Later today (07.04.26) morning we received a phone call from a unknown mobile number having Mobile No 9126519149 and demanded Rs 4 (four) Lakhs to released Afjal and also inform that after getting Rs 4 lakhs Afjal Hussain will be released otherwise they will kill him. After receiving such phone call, I rushed to Siliguri and search him in every possible place but could not traced. Today (07.04.26) evening, I received a phone call from my family members that in the evening at around 04/05 pm my brother Afjal informed to my brother in law (sisters husband) namely Aminul Islam over mobile phone that the said 10/12 persons kidnapped him from Milan More area and confined him in a room at Devidanga area. He also inform to my brother in law namely Aminul Islam over mobile phone that he heard the conversation of 10/12 unknown kidnapers, among them the name of three kidnapers are (i) Dipak (ii) Nirmal and (iii) Bishnu Basfore.

Hence, I pray to you that kindly arrange to recover brother namely Afjal Hussain at earliest and take necessary legal action against the miscreants who kidnapped by brother and highly obliged.
