Subject: Complaint regarding serious road accident caused
by drunk driving and request for strict legal action.

Respected Sir,

I, Ashok Das son of Ratan Das resident of Samar Nagar near,
GM public school siliguri, would like to bring to your notice a
very serious and unfortunate incident that has caused critical
injury to my sister Mamuni Das (Laxmi Das).

On the night of 29.03.2026 at around 10:00 pm my daughter
sister met with a severe road accident near Radhika Bhawan,
Champasari. The accident was caused by two individuals,
namely Puspendu Bakshi and his associate Pradip pal, who
were riding a scooter (No. WB-74BS8649) in a highly reckless
manner under the influence of Alcohol. Due to their neglect
and drunk driving they hit my sister, resulting in grievous
injuries, her right leg has been completely fractured and her
conditions remain very critical.

Therefore, I humbly request to kindly take strict legal action
against the accused persons for drunk and reckless driving
causing grievous injury. As we are engaged in treatment of patient we
I shall be highly obliged for your prompt and strict action in
this matter.
